Net sales during the April-June quarter was ₹7,050.11 crore compared to ₹6,117.36 crore in the same period a year ago, up 15.24%.

Total expenses during the quarter under review stood at ₹6,259.83 crore as against ₹5,430 crore in the year ago period, up 15.26%.

Cement sales of Ambuja rose by 7.57% to 12.78 million tonne (MT) during the June quarter against 11.88 MT in the year-ago period.

Ambuja Cements said that its board has approved payment of interim dividend of ₹1.60 per equity share of ₹2 each.

Ambuja Cements follows the January-December period as its fiscal year.
