Hosur, July 03, 2017: TVS Motor Company registered a sales growth of 11% increasing from 247,364 units in June 2016 to 273,791 units registered in the month of June 2017.

Two-Wheeler

Total two-wheeler registered growth of 11.8% with sales increasing from 240,236 units in June 2016 to 268,638 units in June 2017. Domestic two-wheeler sales grew by 10.4% increasing from 207,012 units in June 2016 to 228,518 units in June 2017.

Scooter sales of the Company grew by 33.8% from 67,590 units in June 2016 to 90,448 units in June 2017. Motorcycles grew by 17.4% from 95,542 units in June 2016 to 112,146 units in June 2017.

Exports
