

## Shanthi Gears Turnover up by 22 %

The Board of Shanthi Gears Ltd (SGL), a subsidiary of Tube Investments of India Ltd, (TII) met today to discuss the unaudited financial results for the quarter ended 30th June, 2017. The turnover for the quarter was Rs. 56.49 Crores against Rs. 46.42 Crores in the same quarter of the previous year. The Profit before tax for the quarter was Rs. 6.88 Crores against Rs. 6.63 Crores in the same quarter of the previous year.

During the quarter, the Company built its order book by Rs. 64 Crores (PY Rs. 50 Crores). Growth led strategies of enhancing efficiencies, exploring new markets and enlarging customer base has helped the Company to remain focused on a path to steady and sustainable growth.
