## BRIEF PROCEEDINGS OF THE 25<sup>TH</sup> ANNUAL GENERAL MEETING OF BIRLA CABLE LIMITED HELD ON 24<sup>TH</sup> JULY, 2017

The 25<sup>th</sup> Annual General Meeting of the members of the Company was held on 24<sup>th</sup> July, 2017 at 10.00 A.M. at the Registered Office of the Company at Udyog Vihar, P.O. Chorhata, Rewa-486006 (M.P.).

Shri Harsh V.Lodha, Chairman of the Board of Directors took the Chair and presided the meeting in accordance with the Article 65 of the Articles of Association of the Company.

Sixty Seven (67) Members were present in person including Eighteen (18) Body Corporate Members present through their authorised representatives and Six (6) Members were represented by their Proxies.

The quorum was present at the commencement of the Meeting as well as at the time of consideration of each item of business. The Chairman confirmed the compliance with the applicable provisions of the Companies Act, 2013 and rules made thereunder, applicable provisions of the Secretarial Standard on General Meeting (SS-2) issued under Section 118(10) of the Companies Act, 2013 with respect to calling, convening and conducting the Annual General Meeting.

The Register of Directors and Key Managerial Personnel Shareholding maintained under Section 170 of the Companies Act, 2013 read with Rule 17 of the Companies (Appointment and Qualification of Directors) Rules, 2014; the Register of Contracts or Arrangements in which Directors are interested maintained under Section 189 of the Companies Act, 2013; Register of Proxies; Audited financial statement for the year ended 31st March, 2017; Independent Auditors' Report on the audited financial statements of the Company; Secretarial Audit Report; consent for appointment of new Statutory Auditors and Memorandum and Article of Association of the Company, were open and accessible during the continuance of the meeting to any member having a right to attend the Meeting.

The Chairman informed the members that pursuant to provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44

of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has extended to its members facility to exercise their right to vote by electronic means in respect of the business to be transacted at the Twenty Fifth Annual General Meeting. The remote e-voting commenced on 20<sup>th</sup> July, 2017 (at 9:00 am) and ended on 23<sup>rd</sup> July, 2017 (at 5:00 pm). He further stated that Shri Rajesh Kumar Mishra, Practicing Company Secretary or failing him Shri R.S.Bajaj, Practicing Company Secretary was appointed as Scrutinizer for the remote e-voting process.

The Chairman apprised the members about the performance of the Company for the financial year 2016-17 and the prevailing business condition in cable Industry. The Chairman then invited the Members to ask questions, if any, and/or otherwise offer their view/ comments. The queries raised and suggestions made by Members in the Meeting were duly and satisfactorily replied by the Chairman and Officers present in the Meeting.

The Chairman informed the members that the Company has arranged for poll for all those members who are present at the Meeting but have not cast their votes by availing the remote e-voting facility, on all the 4(four) resolutions as mentioned in the Notice of the 25th Annual General Meeting to be passed in this Meeting. Thereafter, all the 4(four) resolutions were proposed and seconded.

Thereafter, the Chairman ordered for a poll to be taken at the Meeting on all the 4(four) resolutions as mentioned in the Notice of 25<sup>th</sup> Annual General Meeting and requested the Scrutinizers to conduct the poll process. Shri Rajesh Kumar Mishra, Practicing Company Secretary and Shri Hemant Singh, Chartered Accountant in Practice were appointed as Scrutinizers for conducting poll and were requested by the Chairman for orderly conduct of the voting.

After completion of the poll process, the Chairman informed that the combined results of remote e-voting and poll would be declared by Shri Deepan Gupta, Member of the Company on 25<sup>th</sup> July, 2017 at 10.00 A.M. at the Registered Office of the Company.

On the basis of consolidated Scrutinizer's report on remote e-voting and poll dated 24<sup>th</sup> July, 2017, Mr.Deepan Gupta, Member announced the combined results of remote e-voting and poll on 25<sup>th</sup> July, 2017 at 10.00 A.M. at the Registered Office of the Company.
