Summary of Proceedings of 10th Annual General Meeting

Proceedings of the Tenth Annual General Meeting of Orient Green Power Company Limited held on Wednesday, 09th August 2017 at 3.00 P.M. at Kamakotti Hall, Sri Krishna Gana Sabha, 20, Maharajapuram Santhanam Road, T Nagar, Chennai - 600 017

Mr. N Rangachary, Chairman of the Company took the Chair. The Chairman extended a warm and hearty welcome to shareholders present at the Annual General Meeting (AGM) of the Company. The requisite quorum being present, the Chairman called the Meeting to Order. He then introduced the other Directors, Chief Financial Officer and Company Secretary who were seated on the dais.

The Chairman further informed the Members that the Registrar of Contracts, Register of Members, Directors and Key Managerial Personnel and Proxies are kept open for the purpose of inspection by the Shareholders during the meeting. With the permission of the Shareholders, the Chairman took the Notice as read.



Mr. K. V. Kasturi, Chief Financial Officer, read the "Emphasis of Matter" as in the Auditors' Report of the Company for the year ended 31st March 2017.

Pursuant to Rule 44 of SEBI (LODR) Regulations 2015 and in terms of provisions of the Companies Act, 2013, the Company had provided e-voting facility to the members, and for those who have not exercised their vote through e-voting, facility to cast vote via poll was provided at the venue of the AGM by the Company.

He then informed the shareholders that Mrs. B Chandra, Practicing Company Secretary, Chennai was appointed by the Board, as an Independent Scrutinizer for the voting process at the AGM.

Mr. S. Venkatachalam, Managing Director was invited to make presentation on the performance of the Company and also highlighted on the disinvestment proposal to be carried out by sale of its biomass business to SVL Limited (Promoter Company) and / or its Subsidiaries/ Associates. After the presentation, the Chairman invited comments and queries from the shareholders, and thereafter Mr. S. Venkatachalam, Managing Director of the Company provided necessary clarifications with regard to the same.

After the discussions, the shareholders who had not earlier voted through e-voting process were provided time to cast their votes on resolutions through poll.

The following resolutions were set out in the Notice of the Annual General Meeting dated 30th June, 2017:

Ordinary Business:

1. To receive, consider and adopt the Audited Financial Statements, including Cash Flow Statement of the Company, for the Financial Year ended 31st March, 2017, and reports of the Board of Directors and Auditors thereon.
2. To appoint a Director in place of Mr. S. Srinivasan (DIN: 00014652) who retires by rotation at this meeting and being eligible, offers himself for re-appointment.
3. To appoint M/s. G.D.Apte, Chartered Accountants, as the Statutory Auditors and fix remuneration.

Special Business:

4. Re-appointment of Mr. S. Venkatachalam as the Managing Director of the Company for a further period of 3 years.
5. Payment of Management Fee to SVL Limited.

Mrs. B Chandra, Practicing Company Secretary, scrutinized the voting process (remote e-voting and voting at the AGM venue). Chairman informed the Shareholders that the combined results of e-voting and poll will be made available to members by way of intimating to the Stock Exchanges and also on the websites of the Company within 48 hours of the meeting.

The Chairman thanked the members of the Company for their participation and continued support and announced the formal closure of the Annual General Meeting.

The scrutinizer's report was received and accordingly all the resolution set out in Notice of the 10th Annual General Meeting was passed.
