BSNL sees FY17 revenue holding up

PRESS TRUST OF INDIA New Delhi, August 17... STATE-OWNED BHARAT Sanchar (BSNL) on Thursday said it expects revenue from operations for 2016-17 to be flat at ₹28,477 crore, despite a 'tough' year of intense competition from private players.

ing director Anupam Shrivastava said the company is in the midst of listing its numbers for the financial year ended March 2017 based on Indian Accounting Standards (or Ind-AS) and also partially reconciling the corresponding figures for FY16. The audited numbers and board approvals are expected by end-November or early Decem-

ber. 'As of now, the full details have not come, but what we know is that revenue from operations are ₹28,477 crore for FY17 and ₹28,449 crore for FY16,' Shrivastava told PTI. He said that the full year figure numbers were buoyed by the performance across segments like mobile, broadband and enterprise.

New Delhi, August 17, State-run Bharat Sanchar Nigam (BSNL) on Thursday unveiled its mobile wallet in partnership with Mobikwik to enable one-time bill payments for its over 100 million subscribers. The digital wallet, developed by Mobikwik for BSNL, is in line with the telecom corporation's intent to take the needs of digital payments to rural and urban India, a BSNL statement said.
