This is inform you that, the Nomination and Remuneration Committee of the Board of Directors of the Company, at its meeting held on 10<sup>th</sup> September, 2017 has approved the Grant of 3,45,000 number of stock options to eligible employees of the company, under the Employees stock options plan 2013 (ESOP 2013) at an exercise price of Rs. 10/- per option, each option being convertible into one Equity Share of the Company upon vesting subject to the Security and Exchange Board of India (Share Based Employee Benefits) Regulations, 2014 and the term of the ESOP 2013 Scheme.

The following are the terms of the options granted:

- a) Vesting period: Options granted under ESOP 2013 would vest within a period not less than one year and not more than three years from the grant date of such options. - c) Exercise Period: The exercise period shall commence from the date of vesting and expire not later twelve months from the date of such vesting and such other conditions as per the ESOP scheme 2013.
- d) The shares arising out of the exercise of stock options are proposed to be allotted as and when decision taken by board/Nomination and Remuneration committee as per the ESOP scheme 2013.

The ESOPs granted are governed as per ESOP 2013 plan, which is submitted with the exchanges at the time of obtaining the In-principle approval.
