Q1 FY18 PAT up by 104 % at Rs. 62.9 crore
Q1 FY18 EBITDA MARGIN increased to 9.3% from 8.4%
Q1 FY18 Revenue up by 6.2% at Rs. 1,895.1 crore

Mumbai, August 02, 2017: KEC International Ltd. (KEC), a global infrastructure EPC major, an RPG Group company, today announced its results for the first quarter (Q1 FY18) ended June 30, 2017.

Consolidated Financial Performance (Q1 FY18 V/s Q1 FY17)

REVENUE increased by 6.2% to Rs. 1,895.1 crore from Rs. 1,784.7 crore.

EBITDA increased by 18% to Rs. 176.3 crore from Rs. 149.6 crore.

EBITDA MARGIN increased to 9.3% from 8.4%.

PROFIT BEFORE TAX increased by 79% to Rs. 95.8 crore from Rs. 53.6 crore.

PROFIT AFTER TAX increased by 104% to Rs. 62.9 crore from Rs. 30.9 crore.

The Company's order book as on June 30, 2017 stands at Rs. 13,532 crore. During the quarter, the Company has successfully commissioned several landmark projects in Transmission & Distribution Business, including a 220 kV Transmission Line in Georgia and 400 kV Purnea-Biharsharif Transmission Line in Bihar. In the Substation Business, it has commissioned 400 kV/ 230 kV/ 110 kV GIS Substations in Tamil Nadu.

We are happy with our performance and order intake, especially keeping in mind the uncertainties that were associated with the implementation of GST.
