I Dilip P. Shah, Practicing Chartered Accountant, was appointed as the Scrutinizer by the Board of Directors of the Company pursuant to section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules 2014, for the remote e-voting process in respect of the below mentioned resolutions passed at the AGM of the Company held on Friday, August 11, 2017 at 12.00 noon. I was also appointed as Scrutinizer to conduct the poll process in respect of the poll taken at the said venue of the AGM.

The shareholders of the Company holding shares as on the "cut-off" date August 3, 2017 were entitled to vote on the resolutions as contained in the Notice of the AGM.

The voting period for remote e-voting commenced on Tuesday, August 8, 2017 [9.00 a.m.] and ended on Thursday, August 10, 2017 [5.00 p.m.] and the e-voting platform was disabled thereafter.

After the closure of the voting at the AGM, the report on poll taken at the meeting was generated in my presence and the voting was diligently scrutinized. The votes cast under remote e-voting facility were thereafter unblocked in the presence of two witnesses who were not in the employment of the Company and after the conclusion of the voting at the AGM, the votes cast thereunder were counted.
