Sub: - Financials Results filed on 30th May 2017 reg.

Please refer to the results filed with the Exchange on 30th May 2017 for the year ended 31st March, 2017. In the said financials results, the Earnings per Share (EPS) before movement in Regulatory Balances was stated as Rs.21.21 and after movement in Regulatory Balance was stated as Rs.15.50. It was noticed that EPS value shown in the Profit & Loss Statement (both Standalone & CFS) was inadvertently reported based on the closing number of shares as on 31st March, 2017 instead of calculated based on the weighted average number of equity shares for the year 2016-17. Based on the weighted average, the EPS reported in the Standalone Financial Results shall be read as Rs.19.35 and Rs.14.14 respectively. Similarly, in the Consolidated Financial Results the Earnings per Share (EPS) before movement Regulatory Balances was stated as Rs.21.79 and after Regulatory Deferral Balance as Rs.16.06. Based on the weighted average this shall be read as Rs.19.87 and Rs.14.66 respectively, (Q4 2016-17 EPS Rs.15.54 to be read as Rs.14.17 before Regulatory Balance and Rs.9.82 to be read as Rs.8.96 after Regulatory Balance). The Basic and the Diluted EPS remains the same as the shares are not dilutive.
