नीति आयोग ने कहा है कि भारत में उल्लेख करते हुए शी बेरोजगारी बड़ी समस्या नहीं है बल्कि है कि अधिकतर को देश योग्यता के अनुरुप काम नहीं मिलने (अंडर इम्प्लायमेंट) तथा बेहतर मजदूरी (वेल पेमेंट) देने की चुनौती का सामना कर रहा है और इस पर तुरंत ध्यान देने की जरुरत है।
