Speciality Restaurants Ltd, a leading fine dining restaurant operator with Mainland China, Asia Kitchen by Mainland China, Oh! Calcutta and Sigree-Global Grill as its key brands reported a Total Income from Operations of ₹ 7,221 lakhs for Q1 FY18 as against ₹ 7,860 lakhs in the corresponding quarter of the last year thus marking a de-growth of 8.13% on a y-o-y basis. EBIDTA and Profit after Tax for Q1 FY18 was reported at ₹ (18) lakhs and ₹ (1,582) lakhs respectively.

As on 30th June, 2017, the Company had a total of 103 Restaurants (including 22 franchisees) and 19 Confectionary stores across 19 cities in India, 1 in Bangladesh and 1 in Tanzania. During the quarter ended 30th June, 2017 the Company opened 1 Restaurant (Gong - Modern Asian) and 2 Confectionery (Sweet Bengal).

During the quarter, the Company closed 3 restaurants (Mainland China - 2 Nos. & Sigree Global Grill - 1 No.) and a Confectionery (Sweet Bengal).
