This communication and the Notice of the Meeting are available on the website of the Company at www.vml.org.in and on the website of Karvy at https://evoting.karvy.com.

The remote e-voting facility shall commence on 26th September, 2017 from 9:00 a.m. (IST) and end on 28th September, 2017 at 5:00 p.m. (IST). The remote evoting shall not be allowed beyond the end date and time. Once the vote on a resolution is cast by the Member, the same cannot be changed subsequently.

A person, whose name appears in the register of Members/Beneficial Owners as on the cut-off date i.e. 25th September, 2017 only shall be entitled to avail the facility of remote e-voting as well as voting at the Meeting. The voting rights of Members shall be in proportion to their share in the paid-up Equity Share Capital of the Company as on the cut-off date

Any person who becomes Member of the Company after dispatch of the Notice of the Meeting and holding shares as of the cut-off date i.e. 25th September, 2017, may obtain the User ID and password by sending a request at evoting.varun@karvy.com. 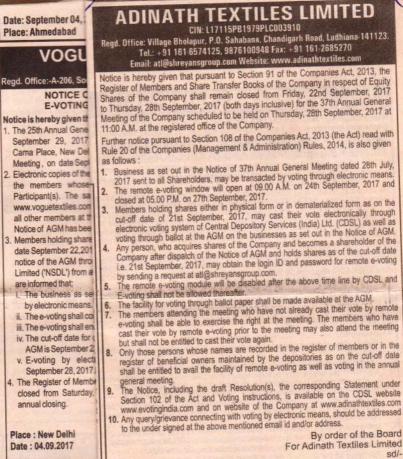
The Members who have cast their vote by remote e-voting may attend the Meeting but shall not be entitled to cast their vote again.

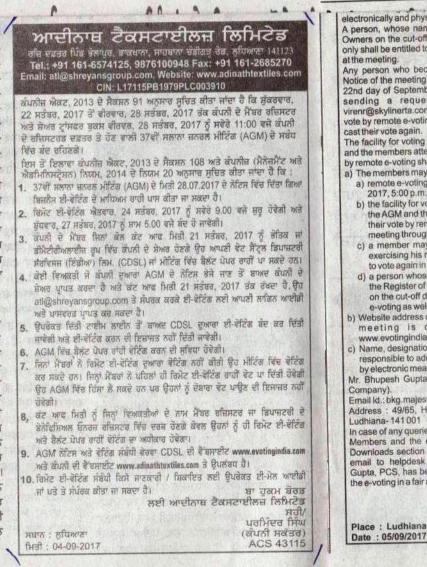
