

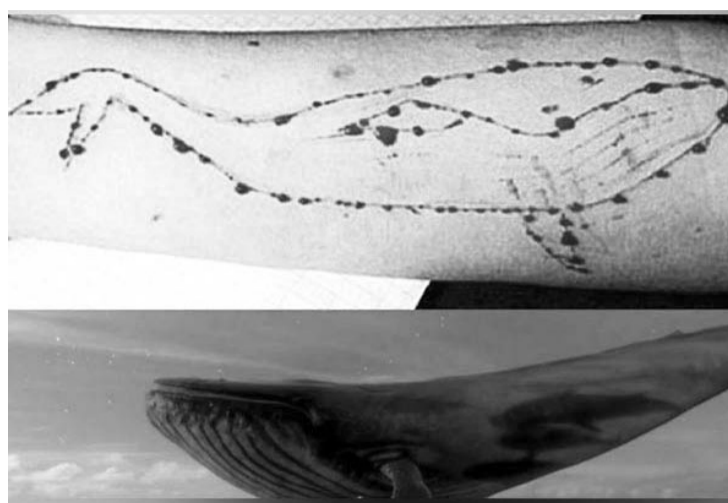

Blue Whale Challenge: Cops set up special cell

Police interrogate Vignesh's friends

Chennai, Aug 31:

Following the death of a college student in Madurai taking part in the online game 'Blue Whale Challenge', the police has set up a special cell to address the issue.

Nineteen-year-old Vignesh had committed suicide by hanging himself inside his house on Wednesday, in order to complete the last challenge of the game. Being the first death reported in the State, the police are interrogating Vignesh's friends to get at the truth.

Vignesh's parents have said that almost 75 other students were playing the game. Vignesh pursuing B Com in a private college in Thiruparankundram was residing with his parents Jeyamani and Vanitha at Kalaikar Nagar at Vilacheri in the district.

On Wednesday afternoon, Vignesh took a friend along to his house for lunch. When his parents returned, they found their son had hanged himself.

The police sent his body to Tirumangalam Government Hospital for a postmortem examination. A preliminary investigation by the police officials found that Vignesh had carved the shape of a whale on his left arm using a sharp object and written the words 'Blue Whale'

Mastermind held in Russia

A 17-year-old girl has been exposed as the alleged mastermind behind the Blue Whale suicide game.

The teenager is accused of being behind the sick craze which has encouraged dozens of vulnerable children to take their own lives.

The unnamed Russian girl, who has now been arrested, issued threats to her victims to murder them or their family members if they failed to obey orders to complete tasks she set them.

The girl was arrested in the Khabarovsk Krai region in south-eastern Russia. Ilya Sidorov, 26, who was also arrested earlier this year has been accused of inciting young girls to take their own lives.

The police also recovered a handwritten note in Tamil that said, 'Blue Whale - this is not a game but a disaster. Once you step inside, you can never leave.'

The challenge, which tells players to perform 50 dangerous tasks, with the final one ending in killing oneself, had taken his life, the police said.

CM to distribute free STBs tomorrow

Chennai, Aug 31:

Chief Minister Edappadi K Palaniswami will distribute Set Top Boxes (STBs) at no cost to subscribers of Tamilnadu Arasu Cable TV Corporation tomorrow. He will also declare open the MPEF4 upgraded control room at Numngambakkam for digital signal transmission through video conferencing from Secretariat.

Among those who would present on the occasion include Deputy Chief Minister O Panner Selvam, Minister for Information & Technology Manikandan.

The Arasu Cable TV subscribers will now get 180 channels at a monthly subscription of Rs 125. The STBs comes with three year warranty.



1 September. The State Transport Department has also sent circulars to all registered automobile dealers in Tamilnadu and has instructed them to not sell or register new vehicle if buyer does not furnish driving licence details. The department has also instructed the RTOs to keep a tab on all dealerships in their jurisdiction so that the new rule is implemented in toto.

But this new order has left future vehicle owners, who do not know driving but make use of a chauffeur,

perplexed. Syra Banu from Porur, a mother of two, says, 'I do not know how to drive and I employ a driver who takes me around town and drops my kids in school. Does this new rule mean I cannot buy a new car?'

Anandan, an octogenarian from Shenoy Nagar, says, 'I'm old and I have a heart condition. It is not safe for me to drive a car and I have not renewed my licence after that. I have a driver for my needs and I prefer registering it under my name than my son's name for income-tax purposes. This new rule will make it impossible for me to own a car. This is nonsense.'

Traffic constable Anburaj, however, has a different view. He says, 'There are a number of people who let their children, who are minors, to drive their car. By making it mandatory to own a licence to buy a car, this will bring down such cases.'

Prostate in septuagenarian treated with laser in city

RG Stone Urology and Laparoscopy Hospital performs rare feat

Chennai, Aug 31:

The team of doctors of RG Stone Urology and Laparoscopy Hospital have performed a rare feat. They have successfully performed endo urological surgery on a 74-year-old man.

During a press briefing here on Wednesday, hospital MD, Dr R Vijay Kumar, who lead the team of doctors, explained the successful procedure.

He said, 'A 74-year-old gentleman came to our hospital with complaints of severe obstructive lower urinary tract symptoms for the last six months. When we diagnosed it, we came to know that he had hugely enlarged prostate gland (280 grams) with retention of urine. After thorough discussion, we planned for an endourological procedure called 'HOLEP - Holmium Laser Enucleation of Prostate.' Using three lobe technique, the prostate lobes were enucleated and pushed into bladder. The lobes were retrieved subsequently by morcellation. He was discharged after four days and is under follow-up.'

'We used 100 watts Holmium laser for the procedure. With this equipment, we can successfully operate any size of prostate gland with minimum blood loss rather than the conventional trans urethral resection of prostate (TURP) in which the same size of gland would have required two or three stages with blood transfusion, long hospital stay and increased

complications,' he added.

Regarding the symptoms of the condition, he said, 'These lower urinary tract symptoms (LUTS) include frequent urination, straining while urinating, urging even after urination, pain or burning during urination, and/or some amount of blood in urine. Prostatectomy is the removal of all or part of the prostate gland.'

'Child sexual abuse on the rise in TN'

Bharat Yatra will be flagged off from Kanyakumari on 11 Sept

Chennai, Aug 31:

The rate of child marriages, trafficking and sexual abuse seems to be a cause for concern as it is running high in Tamilnadu.

According to National Crime Records Bureau (NCRB) and National Family Health Survey (NFHS-3), 2,15,212 girls and 1,64,763 boys are being married off before the legal age. Concerned over it, Noble laureate Kailash Satyarthi Children's Foundation will be undertaking Bharat Yatra which fights child sexual abuse and trafficking.

Addressing mediapersons here on Wednesday, State coordinator of Bharat Yatra, Tamilnadu and Kerala, Paul Bhaskar said, 'Child trafficking is an alarming issue in

our country today. It needs to be highlighted across the country. Rampant trafficking of young girls and migrants from various parts of India are used in flesh trade. We need to work towards ensuring the availability of good quality, free education and skills training for all our children so that they do not get sucked into the vicious cycle of child trafficking, labour and sexual exploitation.'

According to reports between 2013-2015, the number of missing children reported were 10,586. This indicates the amount of child trafficking that takes place and children sold have to endure physical, mental and sexual assault, the organisers said.

Satyarthi's Bharat Yatra will be flagged off from Kanyakumari on 11

September and will culminate in New Delhi on 16 October. The yatra will come to Chennai on 13 September. 'We are launching the yatra to work towards creating India that is safe for our children. We received immense support from Prime Minister Narendra Modi,' said State Yatra committee member K Abdul Ghani.

'Children are the future of our country and enshrine our hopes for a good future. They are our best chance at securing a healthy, peaceful and prosperous nation,' he added.

The yatra is a three year campaign which aims at increasing awareness and reporting cases, ensuring protection for victims and witnesses during trails and increasing convictions of child sexual abuse in a time bound manner.
