Summary of Proceedings of the 39th Annual General Meeting

The 39th Annual General Meeting (AGM) of the members of Kartik Investments Trust Limited ("the Company") was held on Thursday, 28 September, 2017 at 4 p.m. at 'Dare House', No. 2, N.S.C. Bose Road, Parrys, Chennai 600 001. Mr. R Surendran, Chairman took the Chair. The requisite quorum being present, the Chairman called the meeting to order. The Chairman informed that the copies of the AGM notice together with the annual report had been sent to all the shareholders and the Company had provided the remote e-voting facility to the shareholders. He further informed that voting facility at the venue shall be used only by those shareholders who had not exercised their right to vote through remote e-voting.

The notice of the meeting was taken as read with the permission of members since it was already circulated to them. Members were informed that the auditors' report on the financial statement of the Company for the year ended 31 March, 2017 did not have any qualifications or observations or comments or other remarks on financial transactions or matters as having any adverse effect on the functioning of the Company. Accordingly, the auditors' report was not required to be read out at the meeting, as provided in the Act.

The following items of business, as per the notice of AGM dated 1 September, 2017, were transacted at the meeting:

1. Adoption of Financial Statements, Board's Report & Independent Auditors Report for the year ended 31 March 2017.
2. Re-appointment of Mr. R Chandrasekar, as a director retiring by rotation
3. Appointment of Mr. Senthamarai Kannan as the statutory auditor and fixing his remuneration.

The Board of Directors of the Company had appointed Mr. R. Sridharan of M/s. R. Sridharan & Associates, Practicing Company Secretary as the scrutiniser for conducting the remote e-voting and voting process at the AGM.

The Chairman invited queries from members on various agenda items stated in the notice of the meeting. Since there were no queries from the members, the Chairman declared the voting results (remote e-voting and e-voting at the venue of the AGM) and confirmed that all the resolutions were duly approved by the members with requisite majority. The Board of Directors of **Kartik Investments Trust Limited** vide resolution dated 1st September, 2017, pursuant to Sections 108 and 109 of the Companies Act, 2013 read with Rule 20 (as amended) and 21 of the Companies (Management and Administration) Rules, 2014 have appointed us viz. R.Sridharan & Associates, Company Secretaries, as the Scrutinizer to conduct the remote e-voting process for the period commencing from Monday, 25th September, 2017 (9.00 AM) (IST) to Wednesday, 27th September, 2017 (5.00 PM) (IST) and to conduct the Polling process relating to the 39th Annual General Meeting of the members of the Company, held on Thursday, 28th September, 2017 at 4.00 p.m.at Parry House, No.43, Moore Street, Parrys, Chennai - 600001.
