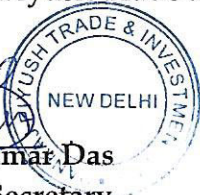

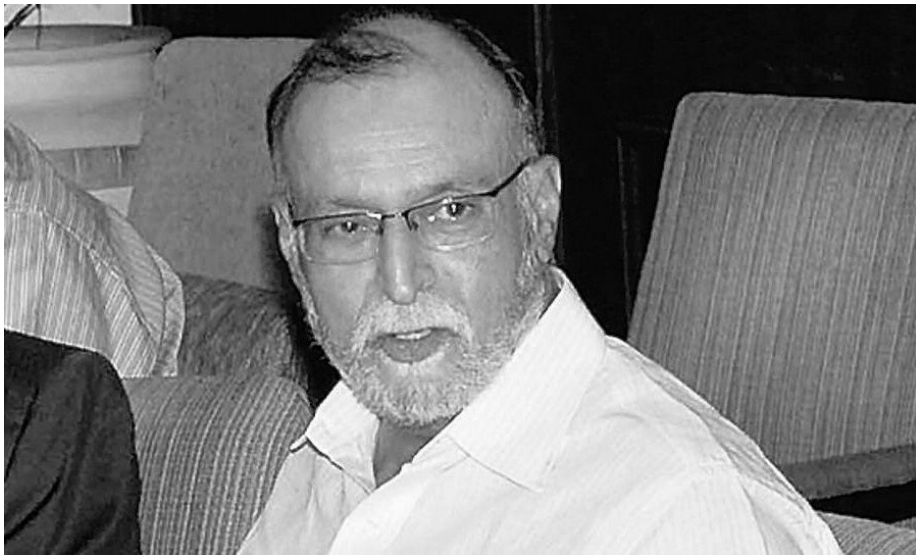
Formulate guidelines to ensure children's safety in schools: Baijal tells Sisodia

New Delhi

Lt. Governor of Delhi Anil Baijal, taking cognizance of the recent unfortunate incidents of sexual assault in schools in the NCR, has in a letter asked deputy chief minister of Delhi Manish Sisodia who also holds the charge of education department, to urgently formulate and enforce guidelines to ensure the safety and security of children in schools.

At the same time the Lt. Governor has also directed the Delhi Police to initiate action to brief and sensitize the field level police officials to visit schools and advise them (school managements) to implement certain safety and security measures in the interest of safety of school students.

He also asked the police



officials concerned to suggest safety/security guidelines to be implemented by schools. According to the police officials concerned there should be safety measures put in place such as verification of antecedents of security

guards/support staff/ employees, employment of adequate number of security guards preferably from ex-servicemen/ authorised private security agencies registered under the Private Security Agencies Regulation

Act, security/safety audit of schools, installation of CCTV cameras at suitable points, proper illumination of dark spots, training modules, etc.

ures listed by the police along with measures suggested by other stakeholders like DCPCR, CBSE and other agencies be considered for inclusion as a set of binding requirements for grant/continuation of recognition of

schools under the Delhi School Education Act and Rules.

He stressed that the safety and security of the children cannot be compromised and has to be an essential condition to allow running of schools in Delhi.

Lt. Governor Baijal also directed the Delhi Police to waive off the specified verification charges for character and antecedent verification of private individuals/ agencies in case of private school employees. As such, the education department was directed to advise all the private recognised schools to avail this facility in a time bound manner.

All departments and stakeholders should work together to ensure a safe and secure environment in schools in Delhi for our children, he further said.

DCW sets up Panel to check open sale of acid

The Delhi Commission for Women (DCW) has set up an expert committee which will prepare a model programme to check the open sale of acid and rehabilitate acid attack survivors.

The 11-member panel will conduct a research on the compliance of various instructions issued by the Supreme Court and governments to prevent the sale of acid.

It will draft a legislation for banning the sale of acid and prepare a model programme for the rehabilitation of acid attack survivors and bringing them into the mainstream, said a DCW official.

The panel will study the best practices and policies in the country or abroad for their rehabilitation, the official said.

"The committee will have



a tenure of three months. It will submit its report to the Commission, which will send its recommendations to the government," DCW chairperson Swati Maliwal said.

Besides Maliwal, the committee includes senior Supreme Court lawyers Rebecca John and Aparna Bhatt.

Man held for entering IGI airport using fake ticket

A 43-year-old man was on Wednesday apprehended by the CISF for entering the Delhi airport allegedly using a fake travel ticket to see his children off.

278 markets in south Delhi to be beautified: SDMC

From street furniture of global standard to modern civic amenities and uniform signboards, the South Delhi Municipal Corporation is dreaming big for beautification of its markets.

South Delhi Mayor Kamaljeet Sehrawat said the SDMC has intensified efforts to beautify all 278 notified markets under its jurisdiction.

"Under the first phase, work has been taken up for 70 markets out of which 20 each fall in Central, South and West Zone of the SDMC, whereas, 10 are in Nazafgarh Zone. The beautification in these 70 markets is scheduled to be completed by September 30," SDMC's Municipal

Commissioner, Puneet Kumar Goel said.

Various upscale markets are located in South Delhi which receives a big footfall daily. The SDMC area is divided into four zones—Central, South and West and Najafgarh.

"As the SDMC has a number of reputed markets under its jurisdiction, hence, these deserve the best street furniture and amenities for customers and citizens," the mayor said, adding, the civic body is keen to make the markets more modern, and friendly for customers and citizens in particular.

Officials said the beautification exercise is being carried out on a "war-footing" to ensure a comprehensive

makeover of these commercial places at the earliest.

"Work on beautification of the rest 208 markets will begin very soon. The SDMC has decided to ensure completion of the works related to the beautification in these markets by March 31, 2018," Goel added.

The SDMC said it intends to become a role model in the field of beautification of markets.

"Street furniture of international standard will be provided in the markets to ensure convenience and satisfaction for visitors and add aesthetic to the surrounding. We intend to turn around our markets as hubs of trade and services," the mayor said.

The departments concerned have been told to impress upon the traders to install uniform signboards to lend a better look to the markets, the SDMC said.

As part of the drive, boundary walls will be built, keeping in view the need of safety and security of customers and traders, public toilets will be maintained to keep them in better working condition, and footpaths will be repaired.

The SDMC has also planned to add green spaces in the markets to give a soothing feeling.

DUSU election result shows youths' support for Congress: Maken

The Delhi Pradesh Congress Committee (DPCC) has hailed the victory of the NSUI candidates for the post of president and vice-president in the Delhi University Students Union elections, describing the victory as youths' support to the Congress party.

This victory has shown that the student community has whole-heartedly accepted the speech given by Congress vice-president Rahul Gandhi in the Berkeley University in the US on 12th September and rejected the speech of Prime Minister Narendra Modi on 11th September, said Ajay Maken, president, DPCC.

We demand immediate re-counting of the votes for the post of joint secretary under CCTV camera, he as-



sured.

Maken said that at the time of counting, it was unofficially announced that three candidates of the NSUI had emerged victorious—for the posts of president, vice-president and joint-secretary—but due to the false protest by the ABVP re-counting was done without camera for the post of joint secretary, and the ABVP candidate was declared winner with a narrow margin.

So we demanded that re-counting for the post of joint-secretary should be held under CCTV camera immediately, or else we will go to court in the matter.

The victory of the NSUI candidates for the post of president and vice-president in the DUSU elections shows that the youth, who helped Modi record a thumping victory in the Lok Sabha elections, has become disillusioned with him, he alleged.

With the direct intervention of the BJP and the BJP-ruled Central Government, effort was made to influence the DUSU elections as for the first time in the history of Delhi University, the DUSU elections were held on a week day, 12th September (Tuesday) instead of at the weekend, like Friday or Saturday, in a bid to make the students listen to Modi's speech on Vivekananda on 11th September and thereby influence the student community of Delhi University, Maken further said.

The rising student vote percentage shows the widening support for the Congress. He said wherever the NSUI has a strong base, like in Punjab and Rajasthan Universities, the NSUI candidates had done well, and the same result has been repeated in Delhi.

MCDs, traffic police to conduct joint anti-encroachment drives

The municipal corporations and the traffic police will jointly carry out anti-encroachment drives in each zone of the municipal corporations.

This was decided at a meeting under the chairmanship of the Lt. Governor, Anil Baijal, to review the encroachment issue here on Wednesday.

At the same time the traffic police will start awareness campaign on enhanced penalties regarding unauthorised parking/encroachment from

14.09.2017 and action from 18.09.2017.

It was decided in the meeting that fines shall be imposed on the violators as per the MV Act as well as DMC Act.

Lt. Governor re-emphasized and directed all the stakeholders that all types of permanent/temporary/built-up/non-built-up encroachments should be removed from these 29 identified stretches, as mandated by the High Court. Further, action for decongestion of the category-B traffic corridors identified by the Task Forces shall

also be initiated from 1st October, 2017. The traffic police was also directed to strictly enforce the policy of no-parking on the declared stretches as per law.

The Lt. Governor emphasized that all agencies concerned and their officers should ensure that the places which are made encroachment-free should not be re-encroached.

He also directed all the municipal commissioners to submit weekly report regarding removal of encroachments/road blocks in their respective stretches.

People have become 'selfish' to earn profit: HC

People, using residential properties for commercial purposes, have become "selfish" as they were earning profits without even thinking of the inconvenience they are causing to their neighbours, the Delhi High Court said on Wednesday.

A bench of Acting Chief Justice Gita Mittal and Justice C Hari Shankar made the observation while expressing concern over the large number of coaching institutes coming up in the residential areas of the city causing "parking woes" and other inconvenience to the local residents.

"It is a very impossible situation. The people living in the city have become selfish for earning profit out of their business. They don't even think about their neighbours," the bench said.

It said that it had made it clear that the law has to be strictly complied with.

"Merely because the master plan permits the private usage or commercial usage in a particular area, does not by any means permit the existing residential properties to

be converted by such users. "No waiver of the Building Bye Laws is allowed. There can be no exception to the mandatory requirements of the Building Bye Laws mandated under the Master Plan.

"Furthermore, while permitting conversion, the authorities are required to take all relevant factors into consideration including nuisance to the neighbours and cannot rest the permission on the sole ground that the Master Plan has permitted such usage," it said.

The court's observation came during the hearing of pleas by Delhi residents Sanjay Singhal and Kanchan

Gupta, who have alleged that over 100 coaching centres were permitted to be run by the MCD in residential properties.

They have also said that these centres were allowed to come up without conforming to the requirements of the master plan for buildings where such user is permitted. Contending that this was completely illegal and ought not to have been permitted, they alleged that it was resulting in overcrowding in the areas and causing "grave nuisance to the bonafide residents."

"The main roads in front of the building being converted into parking space for the students and the employees of the coaching centres, creating bottleneck for the traffic apart from the nuisance due to noise and lack of water and electricity," the petitioners have claimed.

The court had earlier observed that the national capital "will breathe" easier if it stayed all such conversion of residential property for commercial use without adhering to the master plan requirements.

15 juveniles rescued from Rly Stn

Fifteen juveniles have been rescued from the New Delhi Railway Station here in a joint drive by the Delhi Police and NGO Sathi.

The non-governmental organisation had approached the Anti-Human Trafficking Unit of Crime Branch to come to the rescue of the deprived children, the police said in a statement. Sathi is engaged in rescue and rehabilitation of children found at railway stations and platforms across the national capital.

"A ten-day drive was launched on September 1 at the New Delhi Railway Station for rescuing such children. Fifteen such juveniles were recovered," the statement said.

The rescued children went through counselling by the NGO and thereafter, the juveniles expressed a desire to return to normal life and shun the world of crime, it said.

The children were united with their parents yesterday. "The juveniles, aged between 10 to 16 years, belonged to poor family background.

Protest at Myanmar embassy

As many as 300-400 people from different walks of life on Wednesday protested outside the Myanmar Embassy against the alleged persecution of Rohingya Muslims.

Protesters from various organisations, educationists, sociologists etc. had gathered outside the embassy around 2 pm today and after a few speeches and sloganeering, dispersed around 4.30 pm, police said.

The central government is planning to deport Rohingya Muslims, who have come to India from Myanmar, as it considers them illegal immigrants.
