## <u>Sub: Unaudited Financial Results (Standalone and consolidated) for the Quarter ended</u> 30<sup>th</sup> June, 2017

We would like to inform you that pursuant to Regulation 33(3)(a) of SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015, the Unaudited Financial Results (Standalone and Consolidated) for the Quarter ended 30<sup>th</sup> June, 2017, duly approved by Board of Directors of the Company at its Board Meeting on 11<sup>th</sup> August, 2017, was filed under XBRL module as per the regulation.

For the financial year 2017-18, more than 50% of the assets of the Company will be financial assets and more than 50% of the gross income of the Company will be from these financial assets thus the Board of Smartlink at its meeting held on 17<sup>th</sup> March, 2017 had categorized the Company as NBFC and approved an application to be made to Reserve Bank of India for categorizing the Company as Non Systemically Important Non-Deposit taking Company. Accordingly the Company has made an application to RBI and the registration is in progress.

It may further be noted that as per the threshold limits set out in the Companies (Indian Accounting Standards) Rules, 2015 a Non Banking Financial Company (NBFC) whose equity or debt securities are listed on any stock exchange in India or outside India and having net worth less than rupees five hundred crore shall comply with the Indian Accounting Standards (Ind AS) for accounting period beginning on or after the 1<sup>st</sup> April, 2019, with comparatives for the periods ending on 31<sup>st</sup> March, 2019.

Thus as the Company is categorized as NBFC the Ind AS is not applicable for the Company for the Financial Year 2017-18 and 1. Reconciliation of profit and loss; and 2. Financial results as per Ind-AS format; is not applicable.
