Gist of the proceedings of the 29th Annual General Meeting of M/s. Amarjothi Spinning Mills Limited held on 25.09.2017.

The 29th Annual General Meeting of the members of the Company was held on September 25, 2017 at 11 A.M. at the Gayathri Hotel, Kangeyam Road, Tirupur- 641604.

Totally 48 members (including proxies) attended the Meeting as per the records of attendance.

Shri. N.Rajan, Director, Chaired the proceedings of the Meeting. The meeting started with a prayer and thereafter the Chairman welcomed the members and introduced the Board of Directors to the members. The Chairman mentioned that quorum was present and the Register of Directors and Key Managerial Personnel and their shareholding and Register on contracts in which the directors are interested were open for inspection.

The Chairman informed the members that the Auditors' Report on the financial statements and the Secretarial audit Report of the company for the year ended 31st March, 2017 does not have any qualifications or observations. Accordingly, the Reports are not required to be read out before the meeting as provided in the Companies Act, 2013 and Secretarial Standard. The Chairman delivered his speech.

The Chairman informed the shareholders that in accordance with the provisions of Companies Act, 2013 and the amendments to the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided e-voting facility on the CDSL e-voting platform for transacting the businesses contained in the notice. The e-voting commenced at 9.00 A.M. on September 22, 2017 and ended at 5.00 P.M. on September 24, 2017. The Board of Directors had appointed Mr.R.Ramchandrar, Practicing Company Secretary, as scrutinizer for conducting both the e-voting and physical voting processes.

On the invitation of the chairman, Several Members addressed the Meeting, gave suggestions and raised queries on the company's accounts and operations. After getting all the queries, the Chairman of the Meeting gave consolidated reply to the members.

In order to provide an opportunity to those members who had not exercised e-voting, the Chairman ordered for a Poll by the Scrutinizer on all the resolutions. Chairman announced that those members who had not exercised their votes through e-voting, could do so through the physical ballot paper which was made available to them. After conclusion of Poll, Chairman announced that the final results of the voting (after consolidating the result of e-voting and poll) would be announced to the Stock Exchanges and posted on the website of the company within 48 hours.

Ordinary Businesses:


