लामाबाद, 9 सितंबर (भाषा)।
पाकिस्तान की सुप्रीम कोर्ट पूर्व प्रधानमंत्री नवाज शरीफ और उनकी संतानों की ओर से प्रामाणिक मामले में उन्हें (नवाज) अयोग्य ठहराए जाने की चुनौती देने वाली पुनरीक्षा याचिका पर 12 सितंबर को सुनवाई करेगी। शरीफ (67) ने उनके और उनकी संतानों के खिलाफ भ्रष्टाचार के मामलों में शीर्ष न्यायालय द्वारा उन्हें प्रधानमंत्री पद के अयोग्य ठहराए जाने के तुरंत इस्तीफा दे दिया था। सुप्रीम कोर्ट ने 28 जुलाई को उन्हें प्रधानमंत्री पद के लिए अयोग्य ठहराया था। कोर्ट की कार्यसूची में मुताबिक पुनरीक्षा याचिका पर अगले हफ्ते सुनवाई तय की गई है।
