Pursuant to Regulation 30(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that there has been a change in the Statutory Auditor of the Company and we furnish the details as required hereunder.

Reason for change

As per the provisions of the Companies Act, 2013, an audit firm functioning as auditor of the Company for ten years or more after the commencement of provisions of Section 139(2) of the Act, may be appointed in the same Company for further period of three years from April 1, 2014. As maximum statutory tenure of M/s Taunk & Srikanth, Chartered Accountants (Firm Registration No 001524C) to continue as auditors were ended as they were auditors since FY 2000-01 and hence they were not eligible to be considered for re-appointment.

Date & Term of appointment

The Members have approved the appointment of M/s. O P Singhania & Co, Chartered Accountants, Raipur as the Statutory Auditors of the Company at the Annual General Meeting held on 14.09.2017.
