Sub: Consolidated Scrutinizer's Report on e-voting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Rules, 2015 and voting through ballot paper at the AGM of Saraswati Commercial (India) Limited held on Thursday, September 28, 2017 at 4.30 p.m.

I, Nishant Jawasa, of M/s. Nishant Jawasa & Associates, Practicing Company Secretaries, had been appointed as the Scrutinizer by the Board of Directors of Saraswati Commercial (India) Limited. Pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Rules, 2015 to conduct the e-voting process in respect of the below mentioned resolutions passed at the 34th AGM of Saraswati Commercial (India) Limited held on Thursday, September 28, 2017 at 4.30 p.m.

I was also appointed as the Scrutinizer to scrutinize the voting process at the said AGM held on September 28, 2017.

#### Report on Scrutiny:

- 34<sup>th</sup> Annual General Meeting (AGM) of the Members of Saraswati Commercial (India) Limited was held on Thursday, September 28, 2017 at 4.30 p.m. at Oricon House, 6<sup>th</sup> Floor, 12, K. Dubhash Marg, Fort, Mumbai- 400001.
- The Company has appointed National Securities Depository Limited (NSDL) as the Service Provider, for the purpose of extending the facility of Remote E-Voting to the Members of the Company. TSR Darashaw Limited is the registrar and Share Transfer Agent (RTA) of the Company.
- The Service Provider had provided a system for recording the votes of the Members electronically on all items of the business sought to be transacted in the 34<sup>th</sup> AGM of the Company, which was held on Thursday, September 28, 2017.
- The Service Provider had set up electronic voting facility on their website, <a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a>. The Company has uploaded all the items of the business to be transacted at the AGM on the website of the Company and on the website of the service provider to facilitate their members to cast their vote through Remote E-Voting.

- The Company has sent the notices of the AGM along with the Annual report and E-Voting details by email on 4<sup>th</sup> September, 2017 and through courier on 4<sup>th</sup> September, 2017. The Cut-off date for the purpose of identifying the Members who will be entitled to vote on the resolutions placed for approval of the members was 21<sup>st</sup> September, 2017.
- The Notices sent (both through email and physical form) contained the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended.
- As prescribed in the aforesaid Rules, the Remote E-voting facility was kept open for three days from Monday, 25<sup>th</sup> September, 2017 (9:00 a.m. IST) till Wednesday, 27<sup>th</sup> September, 2017 (05:00 p.m. IST) and the NSDL e-voting platform was blocked thereafter.
- As prescribed in clause (v) of sub-rule 4 of the Rule 20, the Company also released an advertisement, which was published 21 days before the date of the AGM in English in 'Financial Express' newspaper dated 5<sup>th</sup> September, 2017 having country-wide circulation and in Marathi in 'Mumbai Lakshdeep' newspaper dated 5<sup>th</sup> September, 2017. The notice published in the newspaper carried the required information as specified in Sub-Rule 4 (v) (a) to (h) of the said Rule 20.
- The Company had provided voting facility to the shareholders present at the AGM through ballot paper who had not cast their vote earlier through e-voting facility.
- After the voting at the AGM was conducted, 1(one) ballot box kept for the purpose of casting of votes was locked in my presence with due identification mark placed by me. The locked ballot box was subsequently opened in my presence and in presence of the two witnesses, as mentioned below, and ballot papers were diligently scrutinized. The ballot papers were reconciled with record maintained by Registrar and Transfer Agents of the company and the authorizations/proxies lodged with the Company. The ballot papers, which were incomplete and/ or which were otherwise found defective have been treated as invalid and kept separately.
- After the closure of the voting at the AGM, the counting of the votes conducted at the venue of the AGM through ballot papers and the votes cast through Remote E-voting facility was duly unblocked by me as scrutinizer in the presence of Ms. Sneha Suryavanshi and Mr. Neeraj Jaiswal who acted as the witness, as prescribed in Sub-Rule 4(xii) of the said Rule 20.
