- 1. The Board of Directors of the Hubtown Limited ("the Company") has passed the resolution on July 31, 2017 for appointing me as a Scrutinizer for conducting the postal ballot voting process.

- 2.1 The Company has completed on August 5, 2017 the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared in the Register of Members/list of beneficiaries as on July 28, 2017. The company has also made arrangement for e-voting with CDSL.
- 2.2 Particulars of all the postal ballot and e-voting forms received from the Members have been entered in a register separately maintained for the purpose.
