[I] MRO-TEK branded telecom products are being upgraded with latest Optical/wireless technology in partnership with a leading foreign company. Along with the technology upgrade, MRO-TEK is aggressively moving into overseas markets.

[II] Electronic Manufacturing Services has been started as a business vertical where MRO-TEK will further utilize its fully equipped electronic manufacturing factory. The Company has already won several contracts to manufacture products at its facility for Indian and foreign companies.

[III] Refurbishing electronic products. Further, utilizing its technical and manufacturing capabilities, the Company is expanding into electronic product refurbishing/resale with warranty. This is a large market with very few organized factories operating in it.

[IV] Large Scale Security Solutions.
