Day, Date, Time and Venue of the Meeting:

The Brief details of the items deliberated at the meeting and result thereof:

- Shri Ramautar Sohanlai Jhawar, Managing Director of the Company, Chaired the proceedings of the meeting.
- The requisite quorum being present, the Chairman called the meeting to order.
- The Chairman then delivered his speech to the members present.
- The Chairman further informed that the Board of Directors have engaged the services
 of Central Depository Services (India) Limited (CDSL) as the authorized agency to
 provide e-voting facility and appointed Mr. Pankaj Trivedi, Company Secretary In
 Practice (Membership No: 15301), Mumbai as the scrutinizer for the purpose of
 Scrutinizing the voting through Ballot paper and remote e-voting process.
- The Chairman informed the Members that remote e-voting commenced at 9:00 a.m. 26th September, 2017 and ended at 5:00 p.m. on 28th September, 2017.

- The chairman informed the members that the facility for voting through physical ballot form is available at the meeting for the members who have not cast their vote through remote e-voting.
