The 33rd Annual General Meeting of the Company was held on Friday, the 29th day of September, 2017 at 11:00 a.m. at Tendulkar Hall, Saraswat Bhavan, Chhatrapati Shivaji Maharaj Marg, Mogul Lane, Mahim (West), Mumbai - 400 016.

Mr. Tarun Jain chaired the meeting. The requisite quorum being present, the Chairman called the Meeting to order. He further informed the Shareholders that the statutory records were kept open for inspection.

With consent of the members present, the notice of the Meeting was taken as read. Ordinary Business:

- Re-appointment of Mr. Tarun Jain (DIN 00053137) as a Director who retire by rotation. 2.
- Re-appointment of Mrs. Pushpa Jain (DIN 00180753) as a Director who retire by rotation. 3.
- Appointment of M/s. Majithia & Associates, Chartered Accountants as Statutory Auditors of the 4. Company for the period of five years.

Special Business:

Appointment of Mr. Atul Jain (DIN 00052966) as Managing Director for a period of three years w.e.f 1st June, 2017.
