The Company has completed the dispatch of Notice and the Annual Report by email to the members whose email address is registered with the Company / Depository Participants on 30th August, 2017 and in physical form to the members whose e-mail id is not registered with the Company / Depository Participants on 30th August, 2017. Notice is hereby given in compliance with the provisions of Section 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 as amended that the Company has offered e-voting facility for transacting all the business through Central Depository Services (India) Ltd. (CDSL) through their portal www.evotingindia.com to enable the members to cast their votes electronically. The remote e-voting period commences on Wednesday, the 20th September, 2017 (09:00 am) and ends on Friday, the 22nd September, 2017 (05:00 pm). No e-voting shall be allowed beyond the said date and time. During this period members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of 16th September, 2017, may cast their vote by remote e-voting. Any person, who acquires shares and becomes member of the Company after dispatch of the notice and holding shares as of the cut-off date i.e. 16th September, 2017, may also obtain the login ID and password by sending a request at helpdesk.evoting@cdslindia.com or RTA, MCS Share Transfer Agent Ltd. However, if the members are already registered with CDSL for remote e-voting then they can use their existing user ID and password for casting their vote. Once the vote on a resolution is cast by the member, the member shall not be allowed to change it subsequently. The facility for voting through ballot paper shall be made available at the AGM and the members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.
