The Company has availed the e-Voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting e-Voting by the Shareholders of the Company.


The voting rights of members are in proportion to their shares of the paid up equity share capital of the Company as on Thursday, September 21, 2017, being the cutoff date.
