## खुल्या भूखंडावरील कचरा साफ न केल्याने चाळीस जणांना नोटीस

खुल्या भूखंडावर साचलेले पाणी आणि कचरा साफ न केल्याच्या कारणावरून महापालिकेच्या आरोग्य विभागाने चाळीस भूखंड मालकांना नोटीस बजावली आहे. दरम्यान, स्वच्छतेबाबत महापालिकेने राबवलेल्या जनजागृती अभियानांतर्गत एक महिन्यात सातशे घरांची तपासणी करण्यात आली.

पावसाळ्यात साचलेल्या पाण्यामुळे डासांची उत्पत्ती वाढून रोगाची साथ पसरण्याचा धोका असतो. त्यामुळे महापालिकेच्या आरोग्य विभागाकडून घरोघरी जाऊन स्वच्छतेबाबत जनजागृती आणि तपासणी केली जाते. महिनाभरात सातशे घरापर्यंत आरोग्य विभागाचे कर्मचारी पोहोचले आहेत. मुख्यमंत्र्यांचा मतदारसंघ दक्षिण-पश्चिम नागपूरमधील काही वस्त्यांमध्ये नियमित कचरा उचलला जात नाही. डासांची उत्पत्ती वाढल्यामुळे रोगराईचे प्रमाण वाढले आहे. सककरदरा परिसरातील बुधवार बाजारपेठ, गावंडे लेआऊटसमोरील मैदानातील बाजार,

महालातील बुधवार बाजार, गोकुळपेठमधील बाजार, इतवारी बाजार या ठिकाणी कचरा साचलेला आहे. यासंदर्भात आरोग्य अधिकारी डॉ. प्रदीप कासावार यांच्याशी संपर्क साधला असता ते म्हणाले की, शहरातील विविध भागातील लोकांच्या घरातील कुलरमधील पाण्याची तपासणी केली जात आहे आणि काही

लोकांना त्याबाबत नोटीस देण्यात आल्या आहेत. सार्वजनिक ठिकाणी किंवा खुल्या भूखंडावर पाणी साचले असेल तर त्या ठिकाणी डेग्यू अळी नष्ट करण्यासाठी फवारणी आणि गप्पी मासे सोडले जात आहे. ४० भूखंडधारकांना आतापर्यंत पाणी आणि कचरा साफ न केल्यामुळे नोटीस देऊन त्यांच्यावर दंडाची कारवाई करण्यात आली आहे.
