- Subject to shareholders approval, the Board approved adjustment of the unsecured loan availed from the promoters against their rights entitlement, including additional subscription, if any.

It is further informed that shareholder's approval for above matter shall be obtained through Extraordinary General Meeting and/or Postal Ballot.
