US gave aid to Pak for 5 yrs, got only lies & deceit: Trump

IN WHAT IS arguably the most severe public indictment ever of Pakistan by a US President, Donald Trump on Monday said that his country has "foolishly" given Pakistan more than \$3 billion in aid over the last 15 years and has got nothing in return but "lies & deceit".

Posting his first tweet of 2018, Trump wrote: "The United States has foolishly given Pakistan more than \$3 billion dollars in aid over the last 15 years, and they have given us nothing but lies & deceit, thinking of our leaders as fools. They give safe haven to the terrorists we hunt in Afghanistan, with little help. No more!"

Trump's tweet was posted at 5:42 pm IST on Monday, and retweeted by more than 14,200 Twitter accounts and liked by more than 34,000 within an hour.

Responding to the remarks, Pakistan's foreign minister Khawaja Masif tweeted at 6:36 pm IST: "We will respond to President Trump's tweet

shortly inshallah... will let the world know the truth... difference between facts and fiction."

Late, Afghanistan's ambassador to the US Hamdulah Mohiuddin tweeted, "President Donald Trump's first tweet of 2018. A promising message to Afghans who have suffered at the hands of terrorists based in Pakistan is far too long."

Trump's tweet comes 10 days after US Vice President Mike Pence, during a surprise visit to Afghanistan, said, "For too long has Pakistan provided safe haven to the Taliban and many terrorist organisations, but those days are over... President Trump has put Pakistan on notice."

The tweet marks a remarkable turnaround from last October when Trump thanked Pakistan for rescuing an American-Canadian family from the Haqqani terror network.

On August 21, Trump said, "We can no longer be silent about Pakistan's safe havens for terrorist organisations, the Taliban, and other groups that pose a threat to the region and beyond... Pakistan has much to gain from partnering with our effort in Afghanistan. It has much to lose by continuing to harbour terrorists."

In its National Security Strategy released on December

19, the US said it will "press" Pakistan to intensify counterterrorism efforts and encourage Islamabad to demonstrate that it is a "responsible steward" of its nuclear assets.

The strategy said that the US continues to face threats from "transnational terrorists and militants operating from within Pakistan." "We seek a Pakistan that is not engaged in destabilising behaviour and a stable and self-reliant Afghanistan. We will insist that Pakistan take decisive action against militant and terrorist groups operating from its soil," the strategy said.

"The prospect for an Indo-Pakistani military conflict that has led to a major change remains a key concern requiring consistent diplomatic attention," it said.

Responding to the US strategy, Pakistan's foreign ministry has said, "Pakistan rejects such unfounded accusations that blame facts on ground and trivialise Pakistan's efforts for fighting terrorism and our unmatched sacrifices to promote peace and stability in the region."

In secret order, Pak plans to seize charities operated by Hafiz Saeed

PAKISTAN'S GOVERNMENT PLANS to seize control of charities and financial assets linked to Islamabad leader Hafiz Saeed, who Washington has designated a terrorist, according to officials and documents reviewed by Reuters.

Pakistan's civilian government detailed its plans in a secret order to various provincial and federal government departments on December 19, three officials who attended one of several high-level meetings discussing the crackdown told Reuters.

Marked 'secret', a December 19 document from the finance ministry directed law enforcement and governments in Pakistan's five provinces to submit an action plan by December 28 for a "takeover" of Saeed's two charities, Jamaat-ud-Dawa (JUD) and the Fatah-ul-Islami Foundation (FIF).

The United States has labelled JUD and FIF "terrorist fronts" for Lashkar-e-Taiba (LeT), a group Saeed founded in 1987 and which Washington and India blame for the 2008 attacks in Mumbai that killed 166 people.

JUD and FIF, interior minister Ahsan Iqbal, who co-chaired one of the meetings on the plan, responded only generally, saying he has ordered authorities "to check the fundraising of all proscribed outfits in Pakistan."

In a written reply to Reuters, he also said Pakistan wasn't taking action under US pressure. "We're not pleasing anyone. We're working as a responsible nation to fulfil our obligations to our people and international community."

Spokesmen for the JUD and FIF both said they could not comment until they receive official notifications of the government's plans. "We don't have any intention about any crackdown so far," FIF spokesman Salman Shahid told Reuters. "No one has asked us about our work or assets."

Saeed could not be reached for comment. He has frequently denied having ties to militant groups and says the charitable organisations he founded and controls have no terrorism ties. He says he promotes an Islamic-oriented government through doing good works.

If the government follows through with the plan, it would mark the first time Pakistan has made a major move against Saeed's network, which includes 300 centres, hospitals, schools, hospitals, a publishing house and ambulance services. The JUD and FIF alone have about 50,000 volunteers and hundreds of other paid workers, according to two counter-terrorism officials.

Participants at the meeting raised the possibility that the government's failure to act against the charities could lead to UN sanctions, one of the three officials said. A UN Security Council team is due to visit Pakistan in late January to review progress against UN-designated "terrorist" groups.

"Any adverse comments or action suggested by the team can have far-reaching implications for Pakistan," the official said.

The December 19 document gave few details about how the state would take over Saeed's charities, pending the plans submitted from the provincial governments. It did say it would involve government entities taking over ambulance services and accounting for other vehicles used by the charities.

Valley encounter ends, Afzal Guru 'badla' was inscribed on gun seized

THE 37-HOUR GUNFIGHT, triggered by the fideyan attack by suspected Jaish-e-Moham mad militants on Central Reserve Police Force's (CRPF) training centre in south Kashmir ended on Monday morning with the killing of a third militant.

On Sunday, five paramilitary personnel and two militants were killed. A video, recorded before the attack, by one of the slain militants also surfaced on social networking sites.

"The operation continued throughout the night. One of the militants who was hiding was killed and the operation was concluded," Special DG, CRPF, NS Srivastava, said. "Since it is a big campus and there are a large number of buildings, the operation is going on. We want to discount chances of anybody hiding there. Though the chances (of any militant hiding) are bleak, we want to be doubly sure."

Srivastava said the militant killed on Monday morning was a foreign national. Security forces found an AK-47 on him with an inscription: "Afzal Guru ka Badla," said CRPF's Ravideep Saha.

The inscription is in line with Jaish's method of linking its attack with the 2013 hanging of Parliament attack convict Afzal Guru. In fact, 2014-15 saw a series of early morning attacks in Jammu and Kashmir where attackers left a note about the attack being a revenge for Afzal Guru's hanging.

Even in the January 2016 attack on Pathankot Air Base, attackers had similarly left a note on Afzal Guru in the car they had

hijacked to reach the Air Base. In the Nagrota camp attack, too, a note was left behind with attackers calling themselves as being part of the "Afzal Guru Squad".

"This is an old play of left to give its attack local favour and absolve Pakistan of any responsibility," a security establishment officer said.

Asked how the militants sneaked inside the highly fortified camp, Srivastava said his troops were alert. "It is because of (our) alertness that they were limited to one or two buildings," he said.

On the intervening night of December 30 and 31, a three-member fideyan group had stormed the CRPF training centre at Lethpora in south Kashmir's Pulwama district. After opening indiscriminate fire and lobbing grenades, the militants took shelter in a building inside the camp.

A fierce gunfight started after the Army and J-K police rushed to the camp to help the paramilitary personnel. Five CRPF personnel were killed — one of them

because of cardiac arrest — and three were injured in the attack. Two militants Fardeen Ahmad Khanday of Tral and Manzoor Ahmad Baba of Pulwama were also killed by Sunday evening. CRPF had lost its commandant Pramod Kumar in the encounter.

"We had intelligence inputs that camps could come under attack. We had increased security. But the camp is still under construction and the boundary wall is not fully complete although the entire campus is fenced and there are patrols throughout. It is due to this alertness of our jawans that we were able to corner them and limit their movement and finally neutralise them," CRPF DG K K Bhatnagar said.

Sources said the campus is spread over 130 acres and has a 4-km perimeter wall. "The militants have scaled the wall and come inside after cutting the concertina wire early on Sunday. That is why the boundary wall is not yet covered with floodlights. The sentry post is about 300 metres away from the place of the breach. It appears the camp had been receded before the attack and militants chose their entry carefully," a senior CRPF officer said.

In that, Khanday prides Jaish and supports the militant saying "if all goes well, by the time my message will reach you, I would be a

guest of heavens of our creator. If you go by Indian security agencies, they say people joining the Mujahideen because of unemployment. This is no more than propaganda." He also referred to the Babri demolition and attacks in Pathankot and Pulwama.

Meanwhile, the attack has forced a rethink within the CRPF about security arrangements at its various camps in Kashmir.

One of its soldiers, Constable P K Panda, who died on Sunday was a veteran of such encounters. Last year, he was given a gallantry medal for a similar operation in Srinagar. Panda had repulsed a militant attack on Independence Day in 2016 at Nowhatta Chowk in Srinagar. CRPF had lost its commandant Pramod Kumar in the encounter.

भारत-पाक के एनएसए की गुपचुप बैठक

जनसत्ता ब्यूरो
नई दिल्ली, 1 जनवरी।

भारत और पाकिस्तान के राष्ट्रीय सुरक्षा सहायक (एनएसए) के बीच शहीदों के नाम बैठक के 48 घंटे के बाद शुरू हो चुका है। इस बैठक में दोनों देशों के आतंकवादियों के नामों के कारण बायोमेट्रिक को लेकर सवाल उठने लगे हैं। दूसरी ओर, पाकिस्तान में आतंकी सरगना बहिन सुद ने जुड़े संस्थानों और वित्तीय संस्थाओं को यहां भी सरकार के द्वारा अलग-अलग में लेने की तैयारी की खबर आई है। बैठक को लेकर भारत और पाकिस्तान की ओर से आधिकारिक बयान नहीं आया है। लेकिन दोनों देशों के अधिकारियों ने नाम उभारने नहीं करने की मुनासिब के साथ कहा कि बैठक अच्छी रही, बायोमेट्रिक सारगर्भक और दोनाना माली में हुई। इस बैठक को दोनों देशों के बीच 'पैकेट' के पीछे की बातचीत' की कवचक का हिस्सा माना जा रहा है।

भारतीय परराष्ट्र अतिरिक्त डोहाल और उनके पाकिस्तानी समकक्ष लेफ्टिनेंट जनरल (रिटायर) नारिस खान जंजुआ के बीच 27 जनवरी को थाईलैंड में दो घंटे तक बैठक

चली। इस दौरान कई मुद्दों पर बातचीत हुई। डोहाल ने सुरसैफ्ट का मुद्दा उठाया, जबकि जंजुआ ने संपर्कविना उल्लंघन की बात उठाई। डोहाल ने अतीरकी सरगना सांकिज सुद का मुद्दा भी उठाया। इस बैठक के बाद राजनयिक मंचल के जल्द ही प्रेषण वार्ता को लेकर दोनों देशों द्वारा कई क्लिपों पर बातचीत होगी। हालांकि, इस कवचक के बीच पाकिस्तान में सीआरपीएफ के खिलाफ पर आतंकवादी हमले से सवाल उठने लगे हैं। इस आतंकवादी हमले को लेकर भारतीय विदेश मंत्रालय ने कोई बयान जारी नहीं किया है।

भारत और पाकिस्तान के रिश्तों में चल रहे तापक के मद्देनजर शहीदों में हुई बैठक को उभारोनी माना जा रहा है। इस बैठक से राजनयिक स्तर पर बातचीत शुरू होने में मदद मिल सकती है। इस बैठक के दो दिन पहले इस्लामाबाद में कुलभूषण जाधव की मुलाकात उनको मां और पत्नी से कराई गई थी। इस मुलाकात के दौरान पाकिस्तानी रक्षक को भारतीय अधिकारियों ने अपमानजनक माना था।

डोहाल से मुलाकात के बाद जंजुआ ने

लौकिक पाकिस्तान के पूर्व प्रधानमंत्री नवाज शरीफ से पांच घंटे तक मुलाकात की। पाकिस्तान में अभी शरीफ की पार्टी पीएमएल (नवाज) की सरकार है। पाकिस्तान की मीडिया ने जंजुआ और शरीफ की मुलाकात के बाद बड़े खबर प्रकाशित की थी कि इसमें पूर्व पीएम ने भारत सतत तामा पड़ोसी देशों के साथ बेहतर रिश्ते बनाने की बात कही थी। भारतीय विदेश मंत्रालय के सूत्रों के अनुसार, इस बात में मंगलवार को अंतिम प्रदान संपन्न है।

चीन मामलों के विशेषज्ञ माने जाने वाले गोखले (58) अपनी विशेष मंत्रालय में सचिव (आधिकारिक संघ) के पद पर अपनी सेवाएं दे रहे हैं। वे 20 जनवरी 2016 में 21 अक्टूबर 2017 तक चीन में भारत के राजदूत रह चुके हैं। उन्होंने विदेश सेवा डोकलाम में भारतीय धरसना और चीन की प्रमुख स्थितिभरन आरंभ (पॉपएर) के बीच 73 दिन तक चले गतिरोध को सुलझाने के लिए भारत-चीन के बीच हुई बातचीत में अहम भूमिका निभाई थी। कार्मिक और प्रशिक्षण विभाग (डीओपीटी) की ओर से नरेंद्र आदेश के मुताबिक, प्रधानमंत्री नरेंद्र मोदी की

हैं। उन्होंने कहा कि सिंधिया वह नहीं बलते कि वे शिलान्यास और वजोनाएं किन सरकारों की देन हैं। वे यहां की जनता को यह भी बयांए कि वे केन्द्र की मोदी व प्रेक्ष प्रेक्ष शिलान्यास सिंह चौहान की सरकारों की वजोनाएं हैं।
