The company is consistently innovating and protecting their inventions under Patents. **The total number of patents granted to the Company in last four years stands at 6 with six more patent pending applications for other products.**

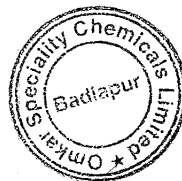
