

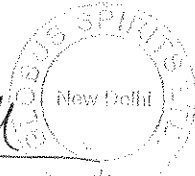

In terms of Regulation 30 and other applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and subsequent to our previous intimations on the above captioned subject vide dated 27th January 2017 and 04th May 2017, we would like to inform you that The Hon'ble Supreme Court of India has dismissed the SLP filed by Excise Department, State of Bihar vide their order dated 19th January 2018, resulting into prevailing of earlier Judgment passed by the Hon'ble Patna High Court vide dated 03rd May 2017, wherein the Hon'ble High Court has set aside the notification passed by Prohibition, Excise & Registration Department, Govt. of Bihar, vide dated 24th January 2017 and further allowed us for filing renewal of Distillery License application and also directed the Bihar State Govt. to consider our renewal application in accordance with the requirement of law. In this regard We have already applied to Bihar excise department for renewing our license to Manufacture ENA and are now awaiting their action complying with the verdict of the Supreme Court .
