- The Group has two reportable operating segments viz. Fragrances and Flavours as per IND AS 108-Operating Segment. Fragrances segment manufactures/trades in fragrances and aroma ingredients for fragrances. Flavours segment manufactures/trades in flavours. The financial information for these segments has been provided in Consolidated unaudited Financials Results as per IND AS 108.
- Subsequent to period end, the Company has entered into an agreement dated 15 January 2018 to acquire upfront 51% of the share capital of Creative Flavours and Fragrances S p A ("CFF"), a leading fragrance company in Italy, for a consideration of Rs 93.12 crores. The remaining stake shall be acquired within three years, consideration for which shall be paid based upon CFF's performance. The acquisition would enable broadening of the group's fragrance business. The financial impact of this acquisition has not been considered in the above
- 5 The Group has decided to restructure its operation at PFW Aroma Ingredients B V (PFW), Netherlands and, inter alia, to relocate part of its production base to India to optimise the cost structure of its fragrance business. This has resulted in partial reduction of PFW's workforce. This termination cost has been considered in full in accordance with Ind As 19-Employee
