Dear Sirs,

Kindly refer to our letter no. JPVL:SEC:2016 dated 18th July, 2016, inter alia, intimating about i) transfer of 500 MW (2x250 MW) Thermal Power Plant located at Bina, District Sagar, Madhya Pradesh (Bina Project) as a going concern basis to its subsidiary Bina Power Supply Limited ("BPSL") through the Scheme of Arrangement ("Scheme"); and (ii) Approval / execution of Securities Purchase Agreement (SPA) between JSW Energy Limited ("JSW") and the Company regarding the sale of entire securities (equity and non-convertible debentures) of its subsidiary i.e. Bina Power Supply Limited ("BPSL") to JSW.

For implementation of the aforesaid Scheme, the Company had sought in-principle approval from Stock Exchange viz. BSE & NSE and vide Observation letter dated November 15, 2016 Stock Exchanges had conveyed their observations/comments.

Further, vide our letter no. JPVL:SEC:2017 dated 12th May, 2017, the Company intimated about extension of long stop date for the completion of transaction of SPA from May 2017 to 31st December, 2017.
