Markets end 3-day losing streak on liquidity boost

EQUITY BENCHMARKS SNAPPED their three-day losing streak on Monday as the RBI announced measures to shore up liquidity amid the government pressing for a change of management at the crisis-hit IL&FS.

The 30-share BSE Sensex soared 299 points in see-saw trade to close at 36,526.14, while the NSE Nifty jumped 77.85 points to reclaim the 11,000-mark. Positive manufacturing PMI data for September and healthy auto sales numbers also reassured investors, brokers said.

Yes Bankwas the top gainer in the Sensex pack, spurting 9.86%, after the mid-sized lender said it is fully geared up to find a successor for its MD and CEO Rana Kapoor, whose tenure was curtailed by the RBI last month.

Shares of IL&FS group companies surged up to 20% on Monday after the government moved the National Company Law Tribunal (NCLT) for change of management at the crisis-hit firm. The NCLT allowed the government's plea to reconstitute the board of Infrastructure Leasing & Financial Services (IL&FS) after market hours on Monday.



"Market rebounded after a weak start with short covering in banking stocks after recent correction and a positive global market. The new trade deal between US and Canada eased trade war concerns and will stimulate sentiment," said Vinod Nair, head of research, Geojit Financial Services.

Bandhan Bank shares crash 20% as **RBI** bars it from opening branches

SHARES OF BANDHAN Bank crashed 20% on Monday as the RBI restrained the company from opening new branches and also ordered freezing of remuneration of its CEO Chandra Shekhar Ghosh for not meeting the licensing conditions. The stock after a weak opening further tumbled 20% to close at ₹451.20 – its 52-week low - on BSE.

At NSE, shares of the company tanked 20% to hit oneyear low of ₹452.20. The stock also touched the lower circuit on both exchanges.

The bank, on its part, said it is taking steps to comply with licensing condition to bring down the shareholding of Non Operative Financial Holding Company in the bank to 40%. "RBI has communicated to us that since the bank was not able to bring down the shareholding of NOFHC to 40%... general permission to open new branches stands withdrawn and the bank can open branches with prior approval of RBI and the remuneration of the MD & CEO of the Bank stands frozen at the existing level, till further notice," it said.

Nifty Realty, Nifty Media and Nifty PSU Bank yield negative returns

Sectoral index

WHILE THE BENCHMARK Nifty50 gained 4.5% in 2018 so far in a narrow rally driven by a handful of stocks, many sectoral indices have given negative returns. Some indices are in such a bad position that each constituent has yielded negative return this year.

Six of the eleven sectoral indices compiled by NSE suffered losses in 2018, with Nifty Realty shedding as much as 37.7%, followed by Nifty Media and Nifty PSU Bank, down 28.3% and 24.4% respectively.

In fact, all the constituents of these three sectoral indices – Nifty Realty, Nifty Media and Nifty PSU Bank – have given negative returns so far in 2018.

Market participants pointed out that concerns of rising interest rates and liquidity crunch seen in the financial systems last week have prompted investors to reduce exposure in these sectors.

According to Siddhartha Rastogi, director of Ambit Asset Management, the largest public sectors banks (PSBs) which have the maximum weightage in the PSU index have had significant write-offs in this financial year.

Moreover, the recent consolidation of PSBs also affected investor sentiment, Rastogi said, adding, "The merger of the


