## Report of Scrutinizer on Remote e Voting and Ballot

I, Anil Kumar Jain, a Chartered Accountant in Practice having office at 64, Priti Nagar, Hisar-125001, Haryana, appointed as Scrutinizer by the Company for the purpose of the remote e voting and voting by ballot process at the meeting. I have examined the records of remote e voting, ballots and other documents required for that purpose.
