GANESHA ECOSPHERE LTD. PLANS TO EXPAND ITS RECYCLING CAPACITY BY 35,000 TPA

Dear Sir,

In compliance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we are pleased to inform you that the Company plans to increase its installed capacity for Pet Bottle Recycling by 35,000 Tons per annum (TPA) at green field location, taking the consolidated recycling capacity of the Company from 1,08,600 TPA to 1,43,600 TPA.

The Company expects the additional recycling capacity to provide a strategic advantage in meeting the increasing demand of company's products domestically and globally among textile, apparel and retail companies.
