A) As confirmed by the Registrar and Share Transfer Agent, there were 4(Four) cases of transfer of shares received during the period from April 1, 2018 to September 30, 2018. All Share Certificates relating to the transfer of Shares received are duly entered in the Memorandum of Transfers/Registers mentioned for the purpose of transfer. However, in 3 (three) cases out of this shares Certificates received as entered in the Memorandum of Transfers have been issued beyond prescribed time limit from respective date of lodgment of each deed.

Further there were no cases for sub-division, consolidation, renewal, exchange or endorsement of calls/allotment monies.

B) As confirmed by the Registrar and Share Transfer Agent, there were no cases of issue of Duplicate share certificates, change of name, transposition, and split of share certificates during the period April 1, 2018 to September 30, 2018.

There was 1(One) case of transmission of shares which was processed with a delay of 27 days from the date of lodgment thereof.
