लेफ्टिनेंट जनरल आसिम मुनीर को बुधवार को पाकिस्तान की ताकतवर खुफिया एजेंसी आइएसआइ का नया प्रमुख नियुक्त किया गया। सेना की मीडिया इकाई ने यह घोषणा की। मुनीर, मिलिट्री इंटेलिजेंस के प्रमुख भी रह चुके हैं। सेना प्रमुख जनरल कमर जावेद बाजवा की अध्यक्षता वाले आर्मी प्रमोशन बोर्ड ने हाल में उन्हें पदोन्नत कर लेफ्टिनेंट जनरल बनाया था। उन्होंने लेफ्टिनेंट जनरल गदीब मुख्तार की जगह ली है। मुख्तार दिसंबर 2016 में आइएसआइ के महानिदेशक बने थे। मुनीर को मार्च 2018 में हिलाल ए इम्तियाज सम्मान दिया गया था। सेना ने शीर्ष स्तर पर कई तबादले की भी घोषणा की। सेना प्रमुख ने पिछले महीने पांच मेजर जनरलों को अगले रैंक में पदोन्नत किया था।

रूस की रिफाइन्री में विस्फोट, एक कर्मचारी की मौत

सराजेवो, 10 अक्टूबर (एएफपी)।

बोस्निया में रूस के तेल शोधक संयंत्र में विस्फोट से एक कर्मचारी की मौत हो गई और नौ अन्य घायल हो गए। पुलिस की एक प्रवक्ता ने बताया कि उत्तरी शहर ब्रॉड में बोस्निया की एकमात्र तेल शोधक संयंत्र में विस्फोट के कारण का अभी पता नहीं चला है। विस्फोट से रिफाइन्री में आग लग गई। आग आधी रात को लगी। प्रवक्ता ट्रेगना केकेज ने कहा, 'एक व्यक्ति की मौत हो गई और नौ लोग घायल हो गए।' उन्होंने कहा, 'छह घायलों को अस्पताल में भर्ती कराया गया है और उनकी जान पर खतरा नहीं है।' स्थानीय स्वास्थ्य केंद्र के प्रमुख जोरान प्रदेजोविक ने कहा कि आठ कर्मचारियों को मामूली चोटें आई हैं। रूस की सरकार नियंत्रित जारुबेजनेफत तेल कंपनी की ब्रॉड रिफाइन्री में बड़ी हिस्सेदारी है। यह रिफाइन्री हर साल 12 लाख टन कच्चे तेल का शोधन करती है।

केन्या में बस हादसा, 50 लोगों की मौत

नैरोबी, 10 अक्टूबर (एपी)।

पश्चिमी केन्या के केरिचो शहर में एक बस पलटने से उसमें सवार 50 लोगों की मौत हो गई। रिफ्ट वैली के प्रांतीय पुलिस प्रमुख फ्रांसिस मुन्याम्बु ने बताया कि बस नैरोबी से पश्चिमी शहर काकामेगा जा रही थी। घायलों का स्थानीय अस्पतालों में इलाज चल रहा है। यह दुर्घटना बुधवार को सुबह करीब चार बजे हुई देश में बढ़ते मध्य वर्ग के कारण वाहनों की संख्या में इजाफा हो रहा है। गाड़ियों की संख्या बढ़ने से हादसे भी बढ़ रहे हैं। आधिकारिक आंकड़ों के अनुसार, केन्या में सड़क दुर्घटनाओं में हर साल करीब 3,000 लोगों की मौत होती है लेकिन विश्व स्वास्थ्य संगठन के अनुमान के मुताबिक यह संख्या 12,000 तक है।

बांग्लादेश की एक अदालत ने बुधवार को 2004 में प्रधानमंत्री शेख हसीना की हत्या की साजिश में भूमिका के लिए विपक्षी बीएनपी प्रमुख खालिदा जिया के भगोड़े बेटे और उनके राजनीतिक उत्तराधिकारी तारिक रहमान को उम्रकैद और पूर्व गृहमंत्री सहित 19 अन्य को फांसी की सजा सुनाई।

विशेष अदालत के न्यायाधीश शाहिद नुरुद्दीन ने पूर्व कनिष्ठ गृह मंत्री लुत्फोजमां बाबर, पूर्व उपशिक्षा मंत्री अब्दुस सलाम पिटू व सेना के कई पूर्व खुफिया अधिकारियों सहित 19 लोगों को मौत की सजा सुनाई। रहमान व 18 अन्य को उम्रकैद की सजा सुनाई गई। ग्यारह अन्य को विभिन्न अवधि की कारावास की सजा दी गई। कुल 49 में से 31 दोषी अदालत में मौजूद थे जबकि 51 वर्षीय रहमान सहित अन्य न्याय का सामना करने से बचने के लिए विदेश भाग गए हैं। रहमान अब बीएनपी के कार्यवाहक अध्यक्ष हैं क्योंकि उनकी मां भ्रष्टाचार के एक मामले में पांच साल के कारावास की सजा काट रही हैं। रहमान पर उनकी गैरमौजूदगी में मुकदमा चला और अदालत ने उन्हें एक भगोड़ा घोषित कर दिया था। वह फिलहाल लंदन में हैं जहां माना जा रहा है कि उन्होंने शरण मांगी है।

लांकि ब्रिटिश अधिकारियों ने उनकी आग्रजन स्थिति के बारे में बताते से इनकार कर दिया है। भ्रष्टाचार मामले में फरवरी में जिया के जेल जाने के बाद रहमान निर्वासन में रहकर मुख्य विपक्षी

पार्टी बीएनपी का नेतृत्व करते रहे। जिया को इस मामले में आरोपी नहीं बनाया गया। इस मामले में रहमान, दो पूर्व मंत्रियों और तत्कालीन बीएनपी नीत गठबंधन सरकार के पूर्व पुलिस व खुफिया अधिकारियों सहित 49 लोगों को आरोपी बनाया गया था। न्यायाधीश ने मुख्य रूप से हसीना पर निशाना लगाने के लिए किए गए हमले की पृष्ठभूमि, मंशा और परिणाम पर 12 बिंदु में टिप्पणियां कीं। न्यायाधीश ने कहा, 'हमले की मंशा शेख हसीना सहित अवामी लीग नेतृत्व को खत्म करने की थी।'

अदालत ने 18 सितंबर को सुनवाई पूरी कर ली थी। जांच में पाया गया कि रहमान समेत बीएनपी नीत सरकार के प्रभावी धड़े ने आतंकवादी संगठन हरकतुल जिहाद अल इस्लामी के आतंकवादियों से यह हमला करने की योजना बनाई थी और हमले को प्रायोजित किया था। फैसले पर टिप्पणी करते हुए बीएनपी महासचिव फखरुल इस्लाम आलामगीर ने गहरी हाताश जताई और कहा कि यह राजनीतिक रूप से प्रेरित फैसला है।

हालांकि विधि मंत्री अनीसुल हक ने कहा कि हमले के मुख्य शूटंत्रकारी रहमान मौत की सजा के हकदार हैं। उनके कैबिनेट सहयोगी और सत्तारूढ़ अवामी लीग के महासचिव ओबैदुल कादिर ने समान विचार रखते हुए कहा, 'हम फैसले से पूरी तरह से संतुष्ट नहीं हैं।' गृह मंत्री असदुज्जमां खान कमाल ने फैसले के बाद संभावदाताओं से कहा, 'हम भगोड़े लोगों को वापस लाने के लिए कदम उठा रहे हैं।'

अधिक नींद लेना मस्तिष्क के लिए खराब हो सकता है

टोरंटो, 10 अक्टूबर (भाषा)।

अधिक सोने से आपके मस्तिष्क के काम करने के तरीके को नुकसान पहुंच सकता है। एक नए अध्ययन में यह बात सामने आई है कि जो कम सोता है या रात में सात से आठ घंटे से ज्यादा की नींद लेता है उसकी समझने-जानने की क्षमता कम हो जाती है। कनाडा के वेस्टर्न विश्वविद्यालय के शोधकर्ताओं का कहना है कि पिछले साल जून में शुरू किए गए नींद संबंधी सबसे बड़े शोध में विश्व भर के 40,000 लोग शामिल हुए।

ऑनलाइन शुरू की गई इस वैज्ञानिक जांच में एक प्रश्नावली और ज्ञानात्मक प्रदर्शन (कान्नेटिव परफॉर्मेंस) वाली गतिविधियों की श्रृंखला शामिल की गई। वेस्टर्न विश्वविद्यालय के एड्रियन ओवन ने कहा, 'हम वास्तव में विश्व भर के लोगों की सोने की आदतों के बारे में जानना चाहते थे। निश्चित तौर पर प्रयोगशालाओं में छोटे पैमाने पर नींद पर शोध हुए हैं लेकिन हम यह जानना चाहते थे कि वास्तविक जगत में लोगों की नींद संबंधी आदतें कैसी हैं।' लगभग आधे प्रतिभागियों ने प्रति रात 6.3 घंटे से कम नींद लेने की बात कही जो अध्ययन के अनुशंसित नींद की मात्रा से एक घंटे कम थी। इसमें चौकाने वाला खुलासा यह हुआ कि चार घंटे या उससे कम नींद लेने वालों का प्रदर्शन ऐसा था जैसे वह अपनी उम्र से

टाइप 2 मधुमेह में यूं तो जीवनशैली में बदलाव करने से फायदा मिलता है लेकिन ऐसा करके हमेशा ही रक्त शर्करा स्तर को नियंत्रण में रख पाना संभव नहीं है। कनाडा के टोरंटो विश्वविद्यालय और स्कारबोरो अस्पताल के चिकित्सकों के मुताबिक 40 से 67 साल आयुवर्ग के तीन लोगों ने योजनाबद्ध तरीके से उपवास रखा। ये मरीज रोग पर नियंत्रण के लिए कई दवाइयां ले रहे थे और इंसुलिन भी नियमित रूप से ले रहे थे। टाइप 2 मधुमेह के अलावा वे उच्च

वाशिंगटन, 10 अक्टूबर (भाषा)।

अमेरिकी राष्ट्रपति डोनाल्ड ट्रंप ने कहा कि संयुक्त राष्ट्र में अमेरिकी राजदूत के तौर पर भारतीय-अमेरिकी निककी हेली की जगह लेने के लिए उनके दिमाग में पूर्व उप राष्ट्रीय सुरक्षा सलाहकार डिना पॉवेल समेत पांच लोगों के नाम हैं।

46 वर्षीय हेली ने मंगलवार को घोषणा की कि वे 2018 के अंत में संयुक्त राष्ट्र में अमेरिकी राजदूत के अपने पद से इस्तीफा दे देंगी। हेली के इस अचानक लिए गए फैसले से व्हाइट हाउस में अधिकतर लोग स्तब्ध हैं क्योंकि उनके पद छोड़ने की योजना का कोई संकेत नहीं था। हेली ने तीन अक्टूबर को अपना त्यागपत्र सौंपा था। ट्रंप ने कहा कि हेली उनकी जगह लेने वाले व्यक्ति को ढूँढने में मदद करेंगी।

राष्ट्रपति अगले दो से तीन सप्ताह में यह चयन कर सकते हैं। एअर फोर्स वन के विमान में संवाददाताओं से बातचीत में ट्रंप ने सूची में शामिल केवल एक अधिकारी का नाम लिया। उन्होंने बताया कि पांच लोगों की सूची में पॉवेल का नाम है। ट्रंप ने बताया कि हमारे पास दरअसल कई नाम हैं। निककी नए चेहरे के चयन में हमारी मदद करने वाली हैं।

पोप फ्रांसिस ने बुधवार को गर्भपात कराने की तुलना भाड़े के हत्यारे को काम देने से की। पोप फ्रांसिस ने वेटिकन में प्रार्थना करने वालों को संबोधित करते हुए कहा, 'गर्भावस्था में हस्तक्षेप करना किसी की हत्या करने जैसा है।' उन्होंने कहा, 'किसी मानव से छुटकारा पाना किसी समस्या को सुलझाने के लिए भाड़े के हत्यारे को काम देने जैसा है।' पोप ने सवाल किया, 'क्या किसी समस्या का समाधान निकालने के लिए भाड़े के हत्यारे का इस्तेमाल सही है?' अपने संबोधन में पोप ने मानव जीवन में गिरावट की शिकायत की। उन्होंने इसके लिए युद्धों, उष्पींडन और अनुपयोगी क्रियाकलाप की संस्कृति और गर्भपात का हवाला दिया।

उन्होंने सवाल किया, 'कोई कृत्य जो निर्दोष जीवन को खत्म करता है, वह उपचारात्मक, नैतिक या मानवीय कैसे हो सकता है?' पोप फ्रांसिस ने इस साल एक विधेयक का विरोध किया था जो अर्जेंटीना में गर्भपात को कानूनी मान्यता देने के लिए लाया गया था।
