# Tata Steel to Back Tata Sponge's Rights Issue

New Delhi: Tata Steel will subscribe to the ₹1,800 crore rights issue floated by Tata Sponge to fund the proposed acquisition of the specialty steel business of Usha Martin, said a senior executive.

The rights issue will be part of the fundraising plan for the acquisition, which is pegged at about ₹4,700 crore. The plan will include debt of up to ₹2,500 crore and issue of non-convertible debentures of up to ₹1,000 crore. "There will be a rights issue to support this kind of expansion and we (Tata Steel) will certainly subscribe to it," Tata Steel's global CEO TV Narendran told media persons at the International Steel Association Conclave in Delhi on Thursday. The development comes at a time when the steel sector is witnessing an upcycle and prices are peaking.
