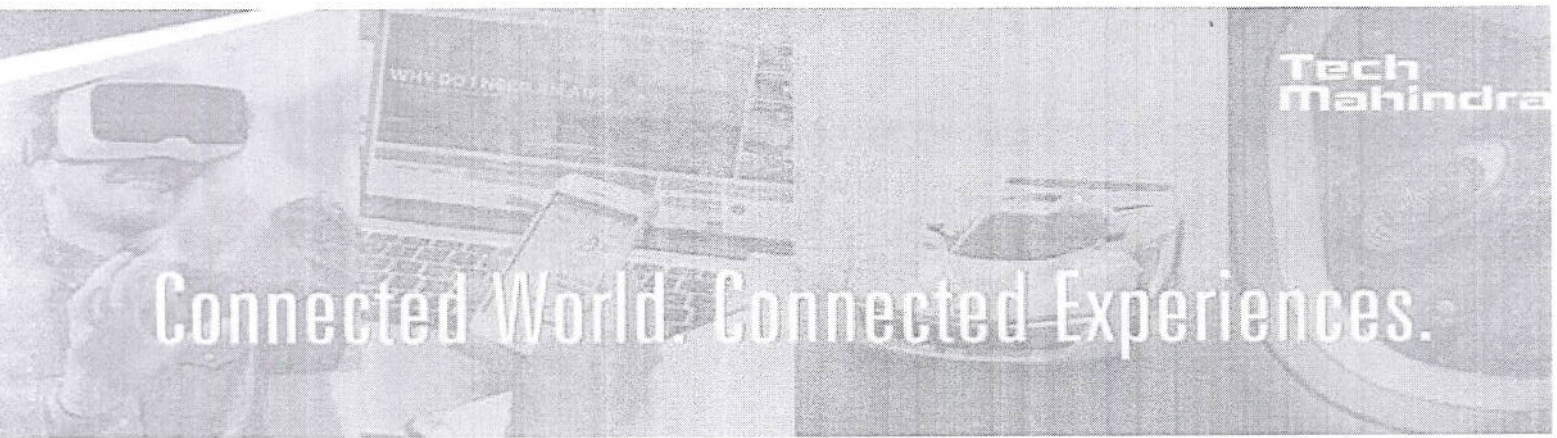

Tech Mahindra Wins Golden Peacock Global Award for Excellence in Corporate Governance 2018

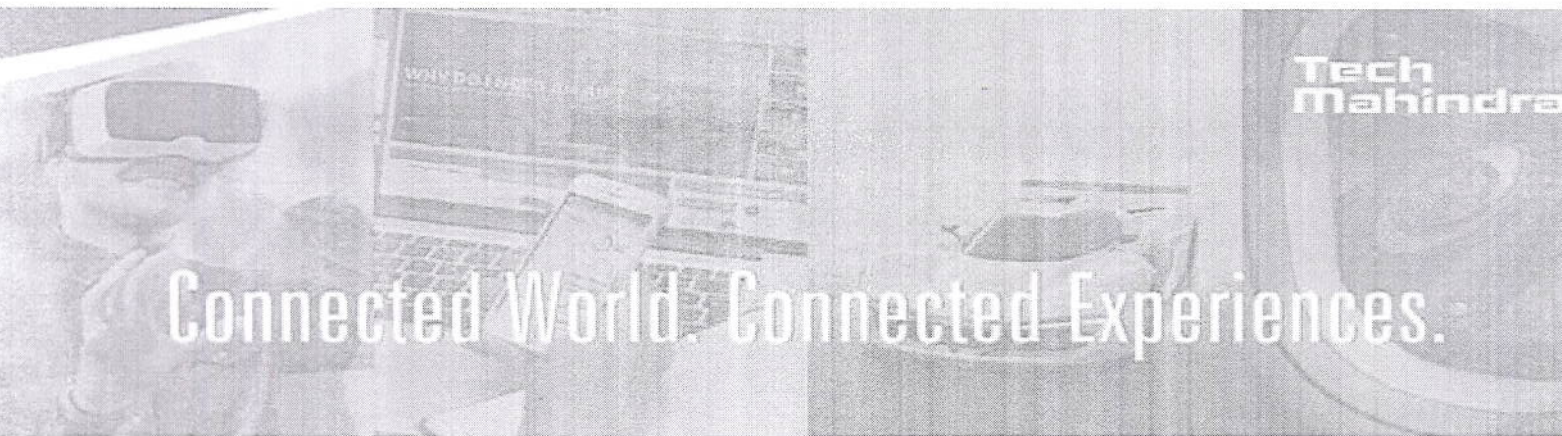
Golden Peacock Awards are regarded as a benchmark of Corporate Excellence worldwide
