Dear Sir/ Madam,

As you may be aware that the Corporate Insolvency Resolution Process ("CIRP") with respect to Diamond Power Infrastructure Limited ("Corporate Debtor" or "the Company") was initiated under the Insolvency and Bankruptcy Code, 2016 read with all the rules and regulations framed thereunder ("Code") by the Hon'ble National Company Law Tribunal, Ahmedabad Bench ("NCLT") vide Order dated 24<sup>th</sup> August, 2018 in the matter titled as 'Bank of India vs. Diamond Power Infrastructure Limited in CP(IB) No. 137/7/NCLT/AHM/2018 and Mr. Ramchandra Dallaram Choudhary was appointed as the interim resolution professional ("IRP").

Further, vide a resolution passed in its first meeting held on 24<sup>th</sup> September,2018, the committee of creditors of the Corporate Debtor filed an application before the Hon'ble NCLT under Section 22 (3) (b) of the Code for replacement of Interim Resolution Professional by Resolution Professional, Mr. Bhuvan Madan (Insolvency Resolution Professional having registration no. IBBI/IPA-001/IP-P01004/2017-18/11655).

The said application for the appointment of the resolution professional has since been admitted by the Hon'ble NCLT and consequent upon such admission the Hon'ble NCLT appointed the undersigned, i.e. Bhuvan Madan as the Resolution Professional ("RP") vide order dated 23<sup>rd</sup> October, 2018 ("Order"). A copy of the said Order is attached herewith and marked as Annexure A.

By virtue of Section 23 of the Code and pursuant to the said Order of the Hon'ble NCLT, I would like to inform you that from 23rd October 2018:

- 1. Subject to section 27, the RP shall conduct the entire CIRP and manage the operations of the Corporate Debtor during the CIRP period, provided that the RP shall, if the resolution plan under sub-section (6) of the section 30 has been submitted, continue to manage the operations of the Corporate Debtor after the expiry of the CIRP until an order is passed by the NCLT under Section 31.
- 2. The resolution professional shall exercise powers and perform duties as are vested or conferred on the Interim Resolution Professional under the Code.
- 3. The Interim Resolution Professional shall provide all the information, documents and records pertaining to the Corporate Debtor in his possession and knowledge to me.

Further, as per Section 17 of the Code, the powers of the Board of Directors of the Corporate Debtor stand suspended and such powers shall be vested with the undersigned. It may further be noted that in consonance with the stipulations contained in Section 14 of the Code, a moratorium has been declared, prohibiting the following:

- (i) the institution of suits or continuation of pending suits or proceedings against the Corporate Debtor including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other authority;
- (ii) transferring, encumbering, alienating or disposing of by the Corporate Debtor any of its assets or any legal right or beneficial interest therein;
- (iii) any action to foreclose, recover or enforce any security interest created by the Corporate Debtor in respect of its property including any action under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002;
- (iv) the recovery of any property by an owner or lessor where such property is occupied by or in the possession of the Corporate Debtor.

The instant intimation w.r.t. initiation of CIRP, appointment of Resolution Professional and declaration of moratorium is for your information and record. We shall keep submitting information/intimation in compliance with the provisions of the Code.

Please also note that all future correspondence in relation to the Corporate Debtor during the CIRP should be addressed to the undersigned, in my capacity as RP in addition to any copies being issued to the office of the Corporate Debtor directly.
