Profits to improve in Near Future: Kumar

He expects profits to improve in the near future. "Though the profit is modest, there is no looking back. From here on, this number will only be bigger and better," said Kumar, alluding to the recovery in the corporate banking segment.

Provisions for bad loans declined to ₹10,185 crore from ₹16,715 crore a year ago, and was lower than ₹13,038 crore in the quarter ended June 2018. Gross NPAs declined from ₹2.12 lakh crore in June 2018 to ₹2.05 lakh crore in the September quarter, but they were still higher than the ₹1.86 lakh crore reported a year earlier.

SBI has an exposure of a little over ₹4,250 crore to the troubled IL&FS group's dozen or so special purpose vehicles. One of these accounts has turned an NPA, for which a ₹56-crore provision has been made.

Net interest income increased 12% to ₹20,906 crore powered by an 11% growth in domestic credit, led by a 14% expansion each in retail as well as corporate advances.

Though fresh slippages were higher than the ₹9,984 crore recorded in the quarter ended June 2018, it was much lower than the ₹25,836 crore reported in the quarter ended December 2017 and a record ₹33,670 crore in January-March 2018.

Non-interest income fell 41% to ₹9,375 crore mainly because of the 73% decline in trading income. Among segmental results, treasury profits fell to ₹510 crore from ₹9,208 crore year ago. Losses from the corporate banking segment shrank to ₹3,728 crore from ₹12,948 crore a year ago.

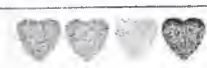

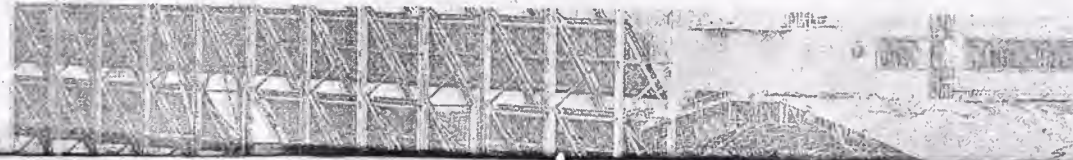
