ক্ষুণ্ণ হচ্ছে সেই সব জায়গাগুলির। রাজনৈতিক ভাবে ফায়দা তুলতে এই ধরনের কাজ করছে বিজেপি। পশ্চিমবঙ্গকে বাংলা করার দাবিতে সরব হয়ে মুখ্যমন্ত্রী সোশ্যাল মিডিয়ায় খোঁচা মেয়ে তীব্র আক্রমণ করেছেন। বাংলার বিজেপি ব্রিগেডকে ফেসবুক পোস্টে তিনি লিখেছেন, যে দলের রাজ্যে কোনও অস্তিত্বই নেই, তারা ঠিক করছে রাজ্যের নাম কি হবে। অথচ বিধানসভায় সর্বসম্মতভাবে রাজ্যের নাম বদলের প্রস্তাব পাশ হয়ে গিয়েছে। নিজের ফেসবুক পেজে করা ওই পোস্টের শেষে মমতা বন্দোপাধ্যায় লিখেছেন, এই বঞ্চনার খুব তাড়াতাড়ি জবাব দেবে রাজ্যের মানুষ। অন্যদিকে, বুধবারই আন্দামান-নিকোবর দ্বীপপুঞ্জের নাম পরিবর্তনের দাবি জানানো হয়েছে। এই দ্বীপের নাম পরিবর্তনের আর্জি জানিয়ে প্রধানমন্ত্রী নরেন্দ্র মোদিকে একটি চিঠি লিখেছেন সুভাষচন্দ্র বসু।
