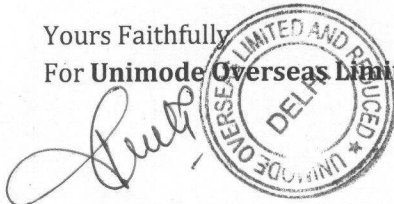

# चिदंबरम परिवार के खिलाफ मुकदमे की मंजूरी से जुड़ा आयकर विभाग का आदेश रद्द

चेन्नई, 2 नवंबर (भाषा)।

कांग्रेस नेता पी चिदंबरम को राहत देते हुए मद्रास हाई कोर्ट ने कालेधन के एक मामले में उनके परिवार के सदस्यों के खिलाफ आपराधिक मुकदमे की मंजूरी देने संबंधी आयकर (आइटी) विभाग का आदेश शुक्रवार को रद्द करते

हुए कहा कि उनके खिलाफ इस संबंध में कोई मामला नहीं बनता। यह मामला चिदंबरम की पत्नी नलिनी, उनके पुत्र कार्ति और पुत्रवधु श्रीनिधि के विदेशी संपत्ति और बैंक खातों के बारे में जानकारी कथित तौर पर गोपनीय रखने से जुड़ा है।

आयकर विभाग के अनुसार

तीनों ने आयकर रिटर्न में ब्रिटेन के कैब्रिज में 5.37 करोड़ रुपए की अपनी संयुक्त संपत्ति का खुलासा नहीं किया था, जो कालाधन व कर धोखाधड़ी अधिनियम के अंतर्गत अपराध है। याचिका जब न्यायमूर्ति एस मणिकुमार और न्यायमूर्ति सुब्रमणिया प्रसाद के पीठ के समक्ष सुनवाई के लिए आई तो पीठ ने

कहा कि इस संबंध में कोई मामला नहीं बनता।
