In continuation to our submission of Press Release dated 3<sup>rd</sup> December, 2018, we would like to inform that the Company has acquired 100% Equity Share Capital of Obra-C Badaun Transmission Limited (OCBTL) from PFC Consulting Limited (PFCCL).

OCBTL was incorporated in August, 2018 by PFCCL to build, own, operate and maintain the transmission project in the State of Uttar Pradesh. The project "Obra-C Badaun Transmission Limited" has approx. 625 ckt kms of line at voltage levels of 765 kV and 400 kV. This project is primarily being constructed to establish Transmission System for Evacuation of Power from 2X660MW Obra-C Thermal Power Project with associated transmission lines. This project has been awarded to the Company through Tariff Based Competitive Bidding Process.
