Skipper bags fresh new orders of over 150 Crores INR for 2500 no. of Telecom Towers

Kolkata, December 18th, 2018: Skipper Limited (BSE: 538562) and NSE (Symbol: SKIPPER), is one of the world's leading manufacturers for power transmission & distribution structures and a prominent manufacturer of Telecom, Railway and Solar structures.

India is the world's second-largest telecommunications market, with around 1.19 billion subscribers as of September 2018. The telecom sector had recently brought out the National Digital Communications Policy that aimed to draw around \$ 100 billion investments across the world by 2022, aimed to support India's move in becoming a digitally empowered economy and society.
