  - Dr. S. Sivaram (72 years) (DIN: 00009900) to be re appointed upto 30<sup>th</sup> September, 2021.
  - Mr. M. K. Sharma (71 years) (DIN: 00327684) to be re appointed upto 31st March, 2022:
  - Mr. Deepak Satwalekar (70 years) (DIN: 00009627) to be re appointed upto 30<sup>th</sup> September, 2023; and
  - Mrs. Vibha Paul Rishi (58 years) (DIN: 05180796) to be re appointed upto 31st March, 2024.

Mr. Narayanan began his career as a management trainee with Hindustan Unilever, where he held numerous positions of increasing responsibility in Sales, Marketing and General Management.
