Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding appointment of M/s.Majeti & Co for conducting transaction audit and its probable completion before 1st Week of December.

Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding appointment of Forensic Auditors M/s.Raju and Prasad by SBI. He also informed the COC Members that the Audit yet to be commenced.

Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding completion of the Sept 2018 Audit.

All the COC Members noted the same.

# 3. TO VOTE FOR THE APPROVAL OF THE RESOLUTION PLAN

Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding the two modifications incorporated in the Resolution plan of M/s.Cosyn consortium from the date of 9th COC meeting i.e.on 12/11/2018

- 1. Increasing the financial commitment for Operational creditors from Rs. 1.00 crore to Rs.2.16 crores
- 2. Reduction of the deferred payment period to Secured creditors from 6 quarters to 4 quarters.

Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding the two modifications incorporated in the Resolution plan of M/s.Cosyn consortium from the email sent by him on 29/11/2018, considering the suggestions of the COC Members

- 1. Page No.28 -Structuring of equity share capital and fresh issue of equity to Resolution applicant. a. The typing errors like mentioning Number of equity shares as Rupees and b. related necessary changes.
- 2. Page No.26- workmen and employees dues as Rs.8.26 crores
- Mr.Prabhakar Nandiraju, Resolution professional informed the COC Members regarding option available to the COC members regarding voting in the meeting or participation through Evoting
- Sri. D.Ram Gopal Rao representing Andhra Bank expressed to convey the following modifications to Resolution applicant for necessary incorporation.
- 1. Reduction of deferred payment period to unsecured creditors from 8 quarters to 4 quarters in tune with the secured creditors.
- Sri. S.Suresh representing Andhra Bank expressed the necessity of conducting one more COC meeting after incorporation of the suggestions.
  - Sri. Vijay Mandhayan representing M/s.Edelweiss, suggested that the revised Resolution plan with modifications will be circulated to all our COC Members through email before opening of electronic voting. He further expressed that, considering the last date of CIRP process is falling on 7.12.2018, conducting another COC for approving of Resolution plan may be difficult due to time constraint.
  - All COC Members took note of the same and approved the suggestion.
- 2. Sri. Sumith sharma representing M/s.Srei Equipment expressed that since their voting rights were reduced and the IA is pending at NCLT Hyderabad, the voting on the Resolution plan may be deferred till the decision of NCLT Hyderabad.
- 3. SRI D.V K DIXITULU representing Y. Sri.Hrish chandra Prasad expressed his satisfaction regarding the prompt and quick service extended by the Resolution Professional during this CIRP period. He specifically mentioned the last minute incorporation of change relating to the capital structure suggested by them on 29.11.18 late evening. All the COC members consented with him regarding the prompt service extended by Resolution professional during this CIRP period.

He further informed that they are abstaining from the voting since their matter is subjudice in NCLT.

The representatives of TDB joined the meeting . Resolution professional briefed them the discussions and approvals given till that time and they also consented for the approvals.

Sri. Vijay Mandhayan representing M/s.Edelweiss, brought to the notice of the COC Members that in all the three plans it is mentioned that all the cases pending against the Corporate Debtor will be droped. He specifically mentioned the NCLAT recent judgment DT.31.07.2018 in company Appeal (AT)(Insolvency) No.306 of 2018 in the matter of Shah Brothers Ispat Private Limited Vs.Mohanraj & Ors. and informed that droping of all cases cannot be possible under the given scheme of things as it is only Civil cases get subsumes with the approval of Resolution plan by NCLT and not criminal proceedings.

- 4. Sri. Umanath representing SBI expressed to convey the following modifications to Resolution applicant for necessary incorporation.
- 1. 100% cash margin for the outstanding Bank guarantees will be provided in-addition to the financial commitment of Resolution plan amount.
- 2.clarification regarding the apportionment of Resolution plan amount for secured creditors
- 3. Reduction of plan period for a period of 12 months from the date of NCLT Order
- 4. increase of upfront amount minimum of 50% Resolution plan amount allocated for Secured creditors.
- 5. The Resolution plan amounts paid will be forfeited, in case failure of the fulfillment of further financial commitment by the Resolution applicant.

Mr.Prabhakar Nandiraju, Resolution professional assured the COC Members regarding bringing to the notice of the Resolution applicant all the suggestions made in this meeting.

He further informed that the revised plan will be circulated probably on sunday i.e. 02.12.2018 morning since the voting lines will be opened on Sunday 02.12.2018 at 4 P.M.

Mr.Prabhakar Nandiraju, Resolution professional circulated the voting rights sheets to all the COC members for exercising their voting on the Resolution plan submitted by M/s. Cosyn consortium
