
Sub: Brief profile of Shri A.S. Rajeev, MD & CEO of the Bank.

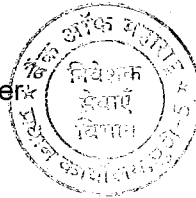

Brief Profile of Shri A.S. Rajeev, MD & CEO

Shri A.S. Rajeev, aged 54 years, assumed charge as Managing Director & CEO of Bank of Maharashtra on 2nd December 2018. Prior to this, he was Executive Director of Indian Bank from 22.01.2016 to 30.11.2018.

Shri A.S. Rajeev is having about three decades of professional banking experience in three Banks, viz., Syndicate Bank, Vijaya Bank and Indian Bank. A qualified Chartered Accountant, he has vast exposure and expertise in all important areas of banking including Corporate Credit, International Banking, Treasury, Risk Management, Credit Monitoring & Supervision, NPA Management, Planning & Development, Human Resources, Finance, Accounts & Taxation, Vigilance, Corporate Governance, Inspection & Audit, Cyber Security and Subsidiaries. After becoming Executive Director of Indian Bank, he was Director of NPCI and two of the Bank's Subsidiaries, M/s. IndBank Merchant Banking Services Ltd. and M/s. Ind Bank Housing Ltd.
